ORDINANCE NO. 34, SERIES 2008

**AN ORDINANCE AMENDING CHAPTER 2 – ARTICLE VI POLICE  
DEPARTMENT SECTION 2.6.1 DESIGNATION OF MARSHAL**

**WHEREAS**, the Town Council (the "Council") of the Town of Timnath (the "Town") currently has the Larimer County Sheriff designated as the Marshal of the Town pursuant to the annual Intergovernmental Agreement between the Town and Larimer County; and

**WHEREAS**, the Town wishes to establish its own Police Department for the health, safety and welfare of its citizen of the Town of Timnath; and

**NOW, THEREFORE BE IT ORDAINED** by the Town Council of the Town of Timnath, Colorado:

**Section 1.** The Town Council hereby repeals Article VI of Chapter 2, Section 2.6.1 of the Timnath Municipal Code and reenacts same subsection to read as follows:

**2.6.1. Designation of Marshal.** The Chief of Police ("Chief") of the Town of Timnath is designated as the Marshal of the Town with the assistance of the Larimer County Sheriff pursuant to the annual Intergovernmental Agreement between the Town and Larimer County.

**Section 2. Severability.** If any article section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance.

**Section 3. Repealer.** All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.

**Section 4. Effective Date.** This Ordinance shall take effect upon adoption at second reading, as provided by Section 3.5.5 of the Charter.
