Subject: event liquor license

To the Timnath Town Council and staff,

I am opposed to the liquor license the town is requesting for Founders Day. I have several comments addressing this issue.

As a certified addictions counselor who works with DUI offenders I know and deal with the fallout from alcohol related events. Making Founders Day into a drinking event comes with a lot of problems.

Founders Day has traditionally been an event that has focused on history and community and kids. At past events, we have had a parade, zucchini races, a tractor show, a hayride history tour and crafts vendors. The original intent of Founders Day was not to make it a liquor event, but a family event that celebrates Timnath's history.

It's disappointing that staff doesn't understand that a public alcohol related event does not fit near residential. Old Town is a unique situation. It's not all businesses and is mostly residential. Many of us have lived here for a lot of years and I think the council needs to consider our quality of life and safety. The question to ask yourselves is, would you want to have this event in your residential neighborhood? Because there are homes on Main St. and 4th St., you are allowing people to drink publically right at someone's doorstep.

We have dealt with events like this in the past with poker runs and know from personal experience how disruptive and awful they can be.

Also, brew fests have a history of clashing with downtown businesses. Business owners on Pine St. in Fort Collins recently opposed the New Brew Fest. One business owner was quoted as keeping "the drunk fest" out.

80-90% of all crimes are committed under the influence of alcohol or drugs. Drinking while impaired, assault, theft, vandalism, and harassment are just some of the crimes more likely to occur. Based on my experience this behavior does not just involve college students.

Please consider moving and changing the name of the event or deny the liquor license.
