ORDINANCE NO. 38, SERIES 2008

**AN ORDINANCE AMENDING CHAPTER 16, ARTICLE 13 OF
THE TIMNATH TOWN CODE CONCERNING ANNEXATION AND
DECLARING AN EMERGENCY**

WHEREAS, the Town of Timnath is a home rule municipality organized pursuant to Article XX of the constitution of the state of Colorado; and

WHEREAS, pursuant to Section 3.6 of the Town of Timnath, Colorado Home Rule Charter the Council may adopt emergency ordinances for the preservation of public health, welfare, peace, safety or property; and

WHEREAS, in the exercise of its authority to adopt ordinances governing land use and development matters, the Town Council has previously adopted Article 13 of Chapter 16 of the Town Code, regarding annexation; and

WHEREAS, the Council finds that certain requirements of said Article 13 are in conflict with proper planning procedures and are unnecessary in light of procedures present in the Colorado Revised Statutes regarding annexation; and

WHEREAS, the Council further finds that it is necessary to immediately amend the Timnath Town Code by the deletion of these conflicting procedures, in order to provide uniform procedures for review and processing of current and future annexation proposals.

NOW THEREFORE, THE COUNCIL OF THE TOWN OF TIMNATH, COLORADO ORDAINS:

Section 1. The above and foregoing recitals are incorporated herein by reference and adopted as findings and determinations of the Town Council.

Section 2. Sections 6.A.12 and 6.A.13 of Article 13, Chapter 16 of the Timnath Town Code are hereby repealed.

Section 3. Emergency declared; effective date. Pursuant to Section 3.6 of the Charter, the Council deems the passage of this ordinance necessary for the immediate preservation of the public health, welfare, peace, safety or property in that the present and immediate future review and processing of annexation proposals would be subject to confusion were the conflicting procedures not immediately repealed. This Ordinance shall be effective upon adoption.


