## AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE TOWN OF TIMNATH FOR THE PURPOSE OF ZONING CERTAIN REAL PROPERTY


That the following property annexed into the Town of Timnath, Colorado, on this date shall be included within the boundaries of the C-2, Community Commercial zone district as follows:
