A RESOLUTION APPROVING THE SECOND AMENDMENT TO INDEPENDENT CONTRACTOR AGREEMENT BETWEEN TOWN OF TIMNATH, COLORADO AND SAFEBUILT COLORADO, LLC FOR BUILDING INSPECTION SERVICES

WHEREAS, the Town Council of the Town of Timnath ("Town") pursuant to C.R.S. § 31-15-103, has the power to pass resolutions; and

WHEREAS, the Town previously entered into that certain Professional Services Agreement dated March 28, 2017 with SAFEbuilt Colorado, LLC, that renews annually and ultimately terminated on December 31, 2022; and

WHEREAS, the Town previously amended that certain Professional Services Agreement dated March 28, 2017 with SAFEbuilt Colorado, LLC as the First Amendment to Independent Contractor Agreement between the Town and SAFEbuilt Colorado, LLC for Building Services, dated January 1, 2020 (the "First Amendment"); and

WHEREAS, attached hereto as Exhibit A is the Second Amendment to Independent Contractor Agreement between the Town and SAFEbuilt Colorado, LLC for Building Services, dated December 13, 2022 (the "Second Amendment"); and

WHEREAS, the Second Amendment extends the services with SAFEbuilt Colorado, LLC for an additional five years, through December 31, 2027, and removes the Code Enforcement Services from the scope of services in favor of those services being entered into in a separate agreement; and

WHEREAS, the Town Council is familiar with the Agreement and finds it to be in the best interest of the Town, its residents, and the general public.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF TIMNATH, COLORADO AS FOLLOW:

Section 1. Approval

The Agreement is hereby approved in substantially the form as attached hereto, subject to technical or otherwise non-substantive modifications, as deemed necessary by the Town Manager in consultation with the Town Planner, Engineer, Legal Counsel, and other applicable staff or consultants.

SECOND AMENDMENT TO INDEPENDENT CONTRACTOR AGREEMENT BETWEEN TOWN OF TIMNATH, COLORADO AND SAFEbuilt COLORADO, LLC

This Amendment to the Independent Contractor Agreement effective March 28, 2017, is entered into by and between Town of Timnath, Colorado, (Town) and SAFEbuilt Colorado, LLC, a wholly owned subsidiary of SAFEbuilt, LLC, (Contractor). Town and Contractor shall be jointly referred to as the "Parties".

Amendment Effective Date: This Amendment shall be effective following full execution by both Parties.

RECITALS AND REPRESENTATIONS

WHEREAS, the Parties entered into an Independent Contractor Agreement (Agreement), by which both Parties established the terms and conditions for service delivery on March 28, 2017; and

WHEREAS, the Parties entered into a First Amendment to the Agreement, effective January 1, 2020, to update the time of performance section and add business license inspection service; and

WHEREAS, the Parties hereto now desire to amend the Agreement in order to extend the term of the Agreement, so that it will automatically renew for five additional one-year terms, through December 31, 2027, unless earlier terminated; and

WHEREAS, the Parties also wish to amend the Agreement to remove Code Enforcement Services from this Agreement, as the Parties intend to enter into a separate agreement for the Code Enforcement Services.

NOW, THEREFORE, for good and valuable consideration, the Agreement is hereby amended as set forth below:

- 1. Section 2.a is hereby amended to read as follows:
- a. This Agreement shall be effective as of March 28, 2017, and shall terminate on the earlier to occur of: (i) termination pursuant to Section 19 hereof, (ii) completion of the Services: or (iii) December 31, 2017. Notwithstanding the foregoing, unless terminated pursuant to (i) or (ii) above, or unless the Town determines not to appropriate funds for this Agreement for the next succeeding year, this Agreement shall automatically renew for each succeeding year for an additional one (1) year term, not to exceed ten (10) years, commencing January 1 of the next succeeding year.
 - 2. After the date of this Second Amendment, Contractor will no longer perform Code Enforcement Services under the terms of the Agreement. All references to Code Enforcement Services and Code Enforcement fees in Exhibit A of the Agreement are hereby removed. In addition, language is added to Exhibit A explaining that building permit fees and project valuations are to be determined based on the International Code Council Building Valuation Data. The attached Exhibit A shall be substituted for the original Exhibit A.
 - 3. All other provisions of the original March 28, 2017 Agreement and the First Amendment shall remain in full force and effect, to the extent not modified by the Second Amendment.

SCOPE OF SERVICES AND COMPENSATION

SAFEbuilt will provide services to the Town using qualified professionals. SAFEbuilt will perform services in accordance with the Town's adopted codes, amendments, ordinances, regulations and standards. Town appoints SAFEbuilt as the sole building official for the Town and grants SAFEbuilt all rights and privileges established by ordinance or statue for this position. The professionals employed by SAFEbuilt will maintain current certifications, certificates, licenses as required for the services that they provide to the Town. SAFEbuilt is not obligated to perform services beyond what is contemplated by this Agreement. SAFEbuilt will perform work at a level of competency in accordance with industry standards.

1. LIST OF SERVICES

Building Official Services

- ✓ Manage and help administer the department and report to the Towns designated official
- ✓ Be a resource for SAFEbuilt team members, Town staff, and applicants
- ✓ Help guide citizens through the complexities of the codes in order to obtain compliance
- ✓ Monitor changes to the codes including state or local requirements and determine how they may impact projects in the area and make recommendations regarding local amendments
- Oversee our quality assurance program and will make sure that we are meeting our agreed upon performance measurements and your expectations
- ✓ Provide training for our inspectors on Town adopted codes and local amendments as needed
- ✓ Main point of contact from SAFEbuilt for the Town and coordinate with other departments
- ✓ Oversee certificate of occupancy issuance to prevent issuance without compliance of all departments
- ✓ Attend staff and council meetings as mutually agreed upon
- ✓ Responsible for reporting for the Town frequency and content to be mutually agreed upon
- ✓ Responsible for client and applicant satisfaction
- ✓ Work with Town staff to establish and/or refine building department and code enforcement processes
- ✓ Provide Building Code interpretations for final approval
- ✓ Issue stop-work notices for non-conforming activities as needed

Building, Plumbing, Mechanical and Electrical Inspection Services

- ✓ SAFEbuilt utilizes an educational, informative approach to improve the customer's experience
- ✓ Perform consistent code compliant inspections to determine that construction complies with approved plans and/or applicable codes and ordinances
- ✓ Meet or exceed agreed upon performance metrics regarding inspections
- ✓ Provide onsite inspection consultations to citizens and contractors while performing inspections
- ✓ Return calls and emails from permit holders in reference to code and inspection concerns

- ✓ Provide ongoing support including review of all plans/plan revisions and be available to the applicant after the review is complete

As-Requested Permit Technician / Administrative Services

- Provide qualified individual to perform the functions of this position with one week advance notice to guarantee service; best effort made by SAFEbuilt to provide service if notice is less than one week
- ✓ Provide coverage for regular Town staff when unavailable due to vacation leave
- ✓ Provide services as directed by the Town and report to the Towns designated official
- ✓ Form and maintain positive relationships with Town staff and maintain a professional image

Code Enforcement Services

Perform the following duties in the enforcement of public nuisance and public safety code-violations:

- -Proactively work with the Town and its citizens to maintain a safe and desirable community
- ✓ Inspect Town for code violations a minimum of once each week
- Urgent response for inspection and notices, as needed
- Respond to and investigate code violation complaints
- ✓ Post violation notices
- ✓ Perform follow up inspections and take appropriate action
- ✓ Organized record keeping and file system
- ✓ Interact with residents and participate in educational activities and customer service surveys
- ✓ Participate in monthly meeting with Community Development Department staff
- Prepare cases for and appear in court, as needed
- ✓ Provide presentations to Town Council and Planning Commission, as needed
- ✓ Provide professional recommendations for code revisions, as needed
- Typical violations include, but are not limited to: junk/trash, extended living in RV, abandoned vehicle, unattached trailer on street, weeds, snow and ice removal, etc.

Reporting Services

SAFEbuilt will continue to provide reporting as previously specified and work to develop requested reports to meet your needs. We can provide monthly, quarterly, and annual reports summarizing activity levels; adherence to our performance metrics; and other items that are of special interest to you.

2. TOWN OBLIGATIONS

- ✓ All fees will be collected by the Town
- ✓ Town will intake permits, plans and related documents for pick up by SAFEbuilt and/or submit to SAFEbuilt electronically
- ✓ Town will provide zoning administration for residential and commercial projects

Emergency Response Services

In cases of natural disaster, SAFEbuilt will provide emergency disaster response. This response will consist of a rapid assessment of the structural integrity of damaged buildings using appropriate forms. The

purpose of these evaluations is to determine whether damaged or potentially damaged buildings are safe for use, or if entry should be restricted or prohibited. SAFEbuilt will post the structure with the appropriate placard and coordinate any disaster or emergency response with the appropriate local, state or federal agency. SAFEbuilt will track all hours and expenses for reimbursement from federal agencies if appropriate.

3. TIME OF PERFORMANCE

Services will be performed during normal business hours excluding Town holidays.

Building permit fees shall be based on project valuation as determined by the International Code Council Building Valuation Data and shall be defined as the total value of all construction work for which the permit is issued, and shall include but not be limited to: all finish work, painting, roofing, electrical, plumbing, heating, air conditioning, elevators, fire extinguishing systems, permanent equipment, architectural/engineering services, and contractor's profit. Project valuation may be adjusted periodically based on economic factors after consultation with the Town.
