PURPOSE

BACKGROUND

The preparation for the Town of Timnath and the Timnath Development Authority 2023 Budgets began in May 2022. Town Council adopted the budget on December 13, 2022.

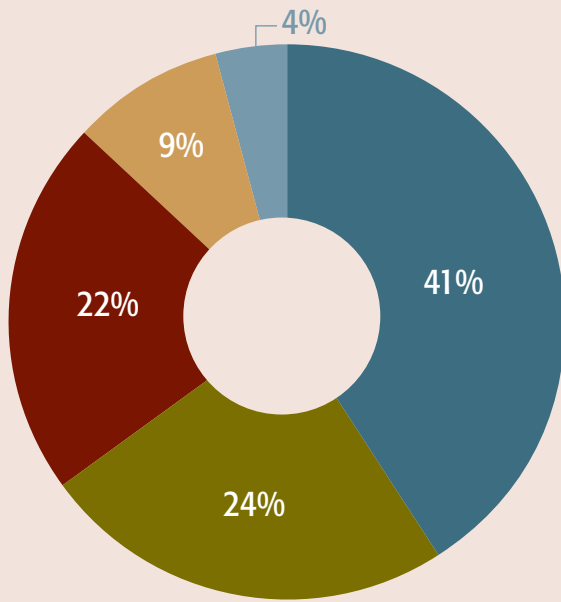

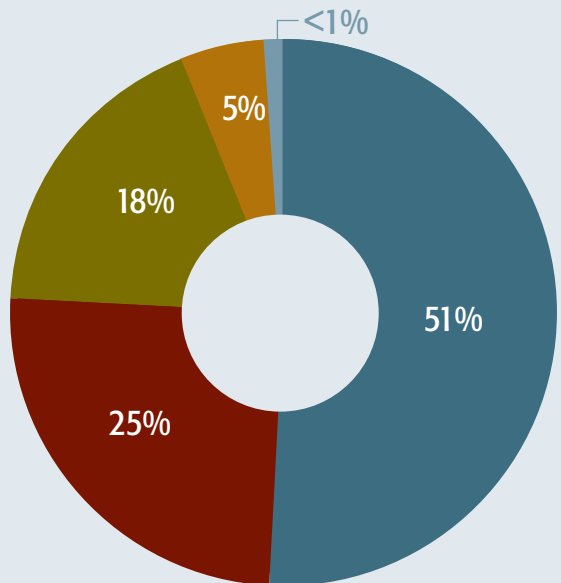

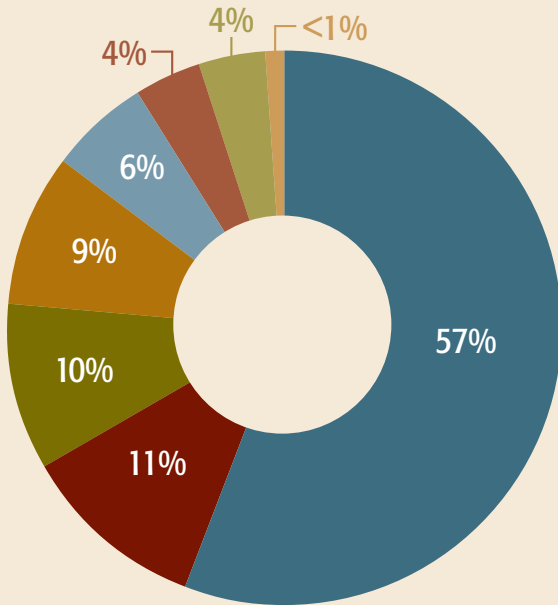

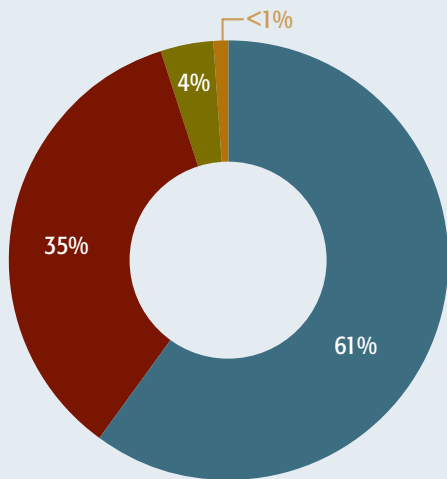

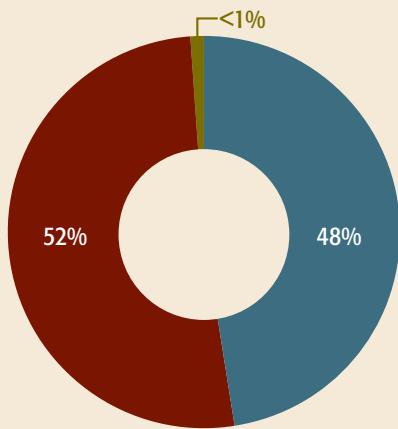

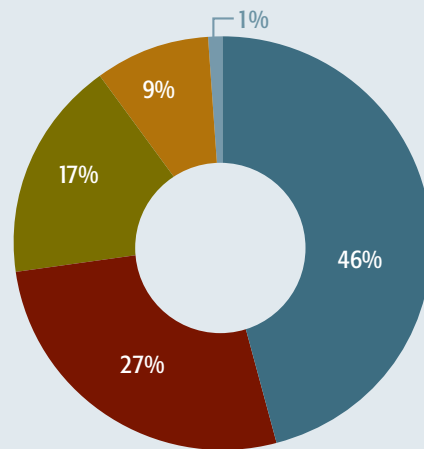
