**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF TIMNATH  
APPROVING THE DISPOSITION AND DISPOSAL OF LOST, ABANDONED OR  
RECOVERED STOLEN PROPERTY**

**WHEREAS**, the Town Council of the Town of Timnath (“Town”) pursuant to C.R.S. § 31-15-103, has the power to pass resolutions; and

**WHEREAS**, the Timnath Police Department is in possession of lost, abandoned or recovered stolen property that requires proper disposition and disposal; and

**WHEREAS**, the Timnath Municipal Code section 10-11-60 directs the Chief of Police to make recommendations to the Town Council as to the disposition of such property; and

**WHEREAS**, the Chief of Police has recommended to the Town Council that the property listed in “**EXHIBIT A**” be disposed of per Town and Department policy; and

**WHEREAS**, the Timnath Municipal Code section 10-11-70 allows the Town Council to direct that property be disposed in the proper manner; and

**WHEREAS**, the Timnath Police Department Policy Manual also details the proper procedure for the release of property.


**BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF TIMNATH, COLORADO:**
