A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF TIMNATH FINDING A PETITION FOR ANNEXATION OF THE PROPERTY KNOWN AS THE POUDRE SCHOOL DISTRICT TIMNATH 50 ANNEXATION TO BE IN SUBSTANTIAL COMPLIANCE WITH THE PROVISIONS OF THE ACT, INITIATING ANNEXATION PROCEEDINGS AND SETTING A PUBLIC HEARING THEREON

Legal Description of Property Proposed for Annexation
