RESOLUTION NO. 25, SERIES 2025**

**A RESOLUTION REAPPOINTING REGULAR COMMISSIONERS WENDY NEWLON AND TOM WOOD TO THE PLANNING COMMISSION; APPOINTING ALTERNATE MICHAEL LOWERY TO A REGULAR COMMISSIONER OF THE PLANNING COMMISSION; AND APPOINTING JANELLE MAINZ TO AN ALTERNATE COMMISSIONER OF THE PLANNING COMMISSION**

**WHEREAS**, the Town Council of the Town of Timnath (the “**Town**”), pursuant to C.R.S. § 31-15-103, has the power to pass resolutions; and

**WHEREAS**, one or more seats are vacant on the Planning Commission and Council wishes to make appointments to fill the vacant position(s) per Timnath Municipal Code, Sec. 2-8-20(c); and

**WHEREAS**, the Chair of the Planning Commission recommended appointment of alternate Michael Lowery as a regular Planning Commission member and Janelle Mainz as an alternate Planning Commission member; and

**WHEREAS**, the terms of Wendy Newlon, Tom Wood, and Michael Lowery as regular Planning Commission members will expire on March 31, 2025, and the Chair of the Planning Commission has recommended reappointments as regular Planning Commission members for an additional four-year term; and

**WHEREAS**, the Town Council, upon review of applications within the last year and/or prior status of serving on the Planning Commission and upon giving consideration to the recommendation by the Chair of the Planning Commission, determines as provided below.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF TIMNATH, COLORADO AS FOLLOWS:**

**Section 1. Regular Planning Commissioner Appointments: April 1, 2025, to March 31, 2029**

The Town of Timnath Town Council approves the appointment of alternate Michael Lowery as a regular member of the Planning Commission for the vacant regular seat which expires on March 31, 2025. The Town of Timnath Town Council reappoints Michael Lowery, Wendy Newlon, and Tom Wood as regular members of the Planning Commission for the term running from April 1, 2025, until March 31, 2029. Appointees may continue to temporarily serve following expiration of their terms until appointment of official members for the next subsequent term.

**Section 2. Alternate Planning Commissioner Appointment: April 1, 2025, to March 31, 2029**

The Town of Timnath Town Council approves the appointment of Janelle Mainz as an alternate member of the Planning Commission. The term of this seat will expire on March 31, 2029. The Appointees may continue to temporarily serve following expiration of their terms until appointments of the next subsequent term.
