


2025 TimnathRecreation Center Proposal

Proposed Location

The proposed recreation center would be centrally located adjacent to the new Timnath Parkway and 4th Avenue. This site is already owned by the Town and would provide convenient access and the opportunity for ample parking.



Many Anticipated Benefits

The new recreation center would have many anticipated benefits, including:

A Sensible Financing Solution

If the Town proceeds with the proposal, a 1.25% sales and use tax measure would be sought. Those funds, along with approximately \$8 million in developer impact fees, would be used to build and operate the \$98 million Timnath Recreation Center.

- √ The proposal is NOT a property tax measure, so there's less burden
 on homeowners
- ✓ A sales and use tax applies to all applicable in-town purchases, including those bought by visitors
- ✓ Timnath's major retailers draw a high volume of out-of-town shoppers
- ✓ A 1.25% sales and use tax adds just 12.5 cents to an applicable \$10 purchase
- ✓ Sales and use tax revenues accumulate faster than property tax revenues
- ✓ Once the construction financing is paid off, the tax would be reduced to 0.25% to help operate and maintain the recreation center

Lowest Area Sales Tax Rates

Timnath's current sales tax rate for food (home consumption) is 2.25% and its tax on building materials and motor vehicle sales is 3.0%. Those rates are among the lowest when compared to neighboring towns.


