



### **Executive Summary**



#### **Purpose**

During the winter of 2025, ETC Institute administered a community survey for the Town of Timnath. The purpose of the survey was to assess resident satisfaction with the delivery of major Town services and to help set priorities for the community.

#### Methodology

The six-page survey, cover letter and postage-paid return envelope were mailed to a random sample of households in the Town of Timnath. The cover letter explained the purpose of the survey and encouraged residents to either return their survey by mail or complete the survey online. At the end of the online survey, residents were asked to enter their home address; this was done to ensure that only responses from residents who were part of the random sample were included in the final survey database.

The goal was to receive 600 completed surveys. This goal was met, with 622 households completing the survey. The results for 622 households have a 95% level of confidence with a precision of at least +/-3.4%.

#### **Major Findings**

**Perceptions of Timnath.** Respondents were most satisfied (rating "satisfied" or "very satisfied") with their perceptions of Timnath in regards to overall feeling of safety (94%), overall quality of neighborhood (90%), and overall quality of life (83%). In regard to overall ratings, Timnath as a place to live (95%), as a place to raise children (93%), and as a place to retire (68%) were rated the highest (as "good" or "excellent").

**Major Town Services.** The three major town services respondents were most satisfied with (rating "satisfied" or "very satisfied") were overall maintenance of Town streets and sidewalks (82%), overall quality of police services (78%), and overall effectiveness of Town communication with the public (76%). The three major town services respondents think are the most important for the town to provide are quality parks and recreation programs/facilities (54%), quality planning, building, and development review processes (42%), and quality police services (41%).

**Customer Service.** Thirty percent (30%) of respondents called or visited the Town with a question, problem, or complaint during the past year. Of those respondents, the highest percentage were satisfied (rating "satisfied" or "very satisfied") with how easy the Town was to contact (88%) and the way they were treated by town employees (87%).

Communications. The three aspects of Timnath communications respondents were most satisfied with (rating "satisfied" or "very satisfied") were availability of information about Town programs and services (74%), efforts to keep residents informed about local issues (71%), and how well the Town's communications meet your needs (68%). The sources of information used most often to obtain information about the Town of Timnath were the Town website (68%), Town weekly email newsletters (58%), and Town's social media sites (50%). Respondents most prefer weekly email newsletters (74%), the Town website (66%), and Town's social media sites (55%).

**Safety and Security.** Respondents feel safest (rating "safe" or "very safe") in their neighborhoods during the day (98%), overall in the community (97%), and in community parks (96%).



**Public Safety.** Respondents feel most satisfied with public safety (rating "satisfied" or "very satisfied") in regards to efforts by police to prevent crime (88%), how quickly fire services respond to emergencies (87%), and overall quality of fire services (86%). The three public safety services most important to respondents were efforts by police to prevent crime (56%), how quickly ambulance and EMS personnel respond to emergencies (47%), and how quickly police respond to emergencies (35%).

**City Growth.** Respondents were most satisfied with City growth in regards to preservation of open space and natural areas (57%), quality of residential development (53%), and rate of growth in Timnath (41%). Over half of respondents (52%) think the rate of growth in Timnath is "too fast."

**Housing.** The housing items the highest percentage of respondents feel satisfied (rating "satisfied" or "very satisfied") with are availability of a range of housing types (55%) and availability of housing options by price range (45%).

**Reasons to Live in Timnath.** The highest percentage of respondents think it is "very important" to live in Timnath because of the safety and security (89%), availability of parks and recreation opportunities (78%), and quality of public schools (78%).

**Parks and Recreation Services.** The three parks and recreation services respondents felt most satisfied with (rating "satisfied" or "very satisfied") were maintenance of Town parks (93%) and appearance of parks and facilities (92%).

**Maintenance and Appearance.** Respondents felt most satisfied with the maintenance and appearance of the town in regards to the condition of street signs and traffic signals (92%) and overall cleanliness of Town streets (92%).

**Code Enforcement.** The code enforcement items respondents felt most satisfied with were enforcement of exterior maintenance of commercial/business property (76%) and enforcement of sign regulations (70%).



#### How the Town of Timnath Compares to Other Communities Nationally

Satisfaction ratings for the Town of Timnath **rated above the U.S. average in 48 of the 52 areas** that were assessed. The Town rated <u>significantly higher than the U.S. average (difference of 5% or more) in all 48 of these areas</u>. 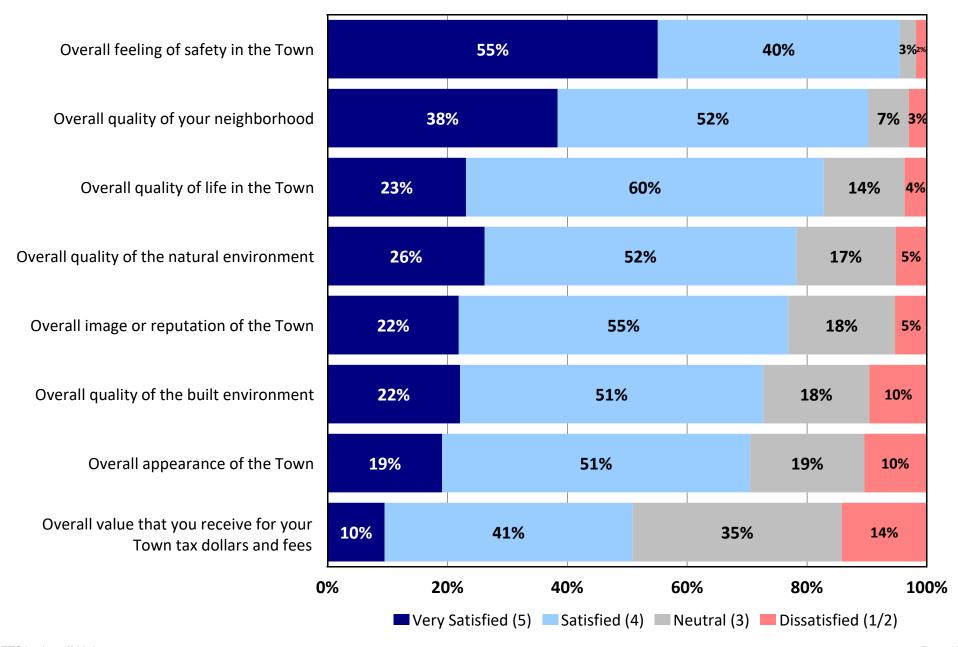

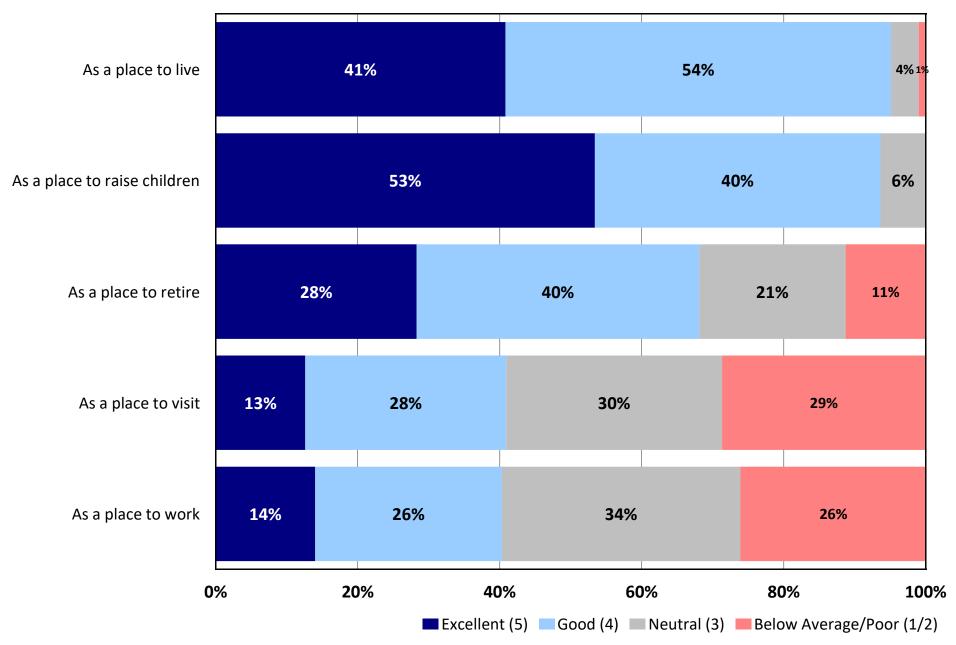
#### **Q1.** Perceptions of Timnath

by percentage of respondents (excluding "don't know")



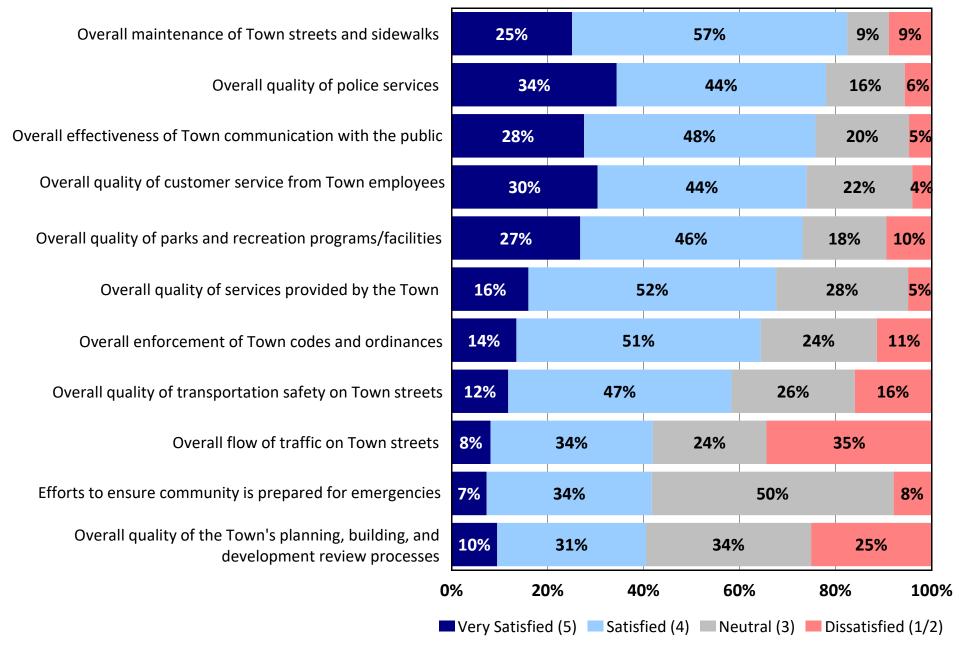
#### **Q4.** Overall Ratings of Timnath

by percentage of respondents (excluding "don't know")



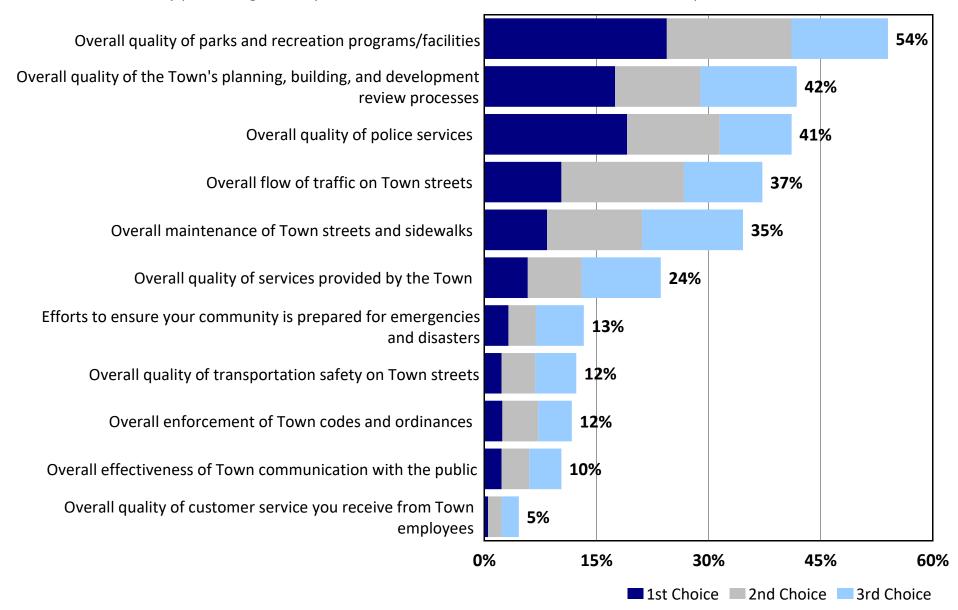

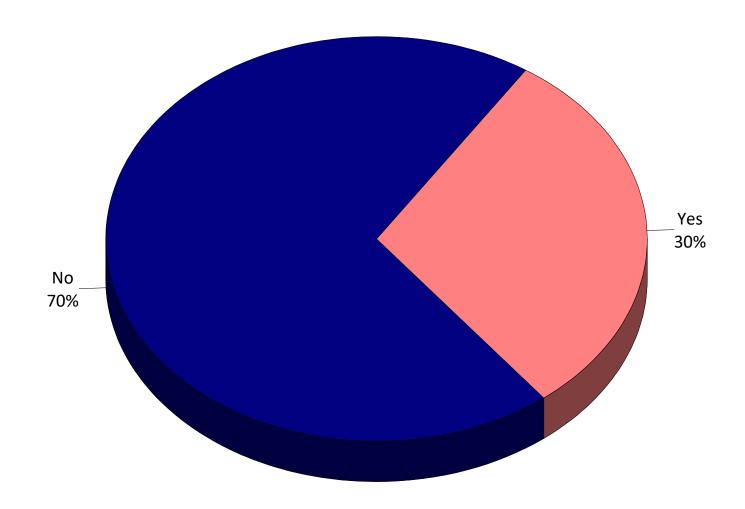
# Q6. Which THREE of the services listed in Question 5 on the previous page do you think are MOST IMPORTANT for the Town to provide?

by percentage of respondents who selected the item as one of their top three choices



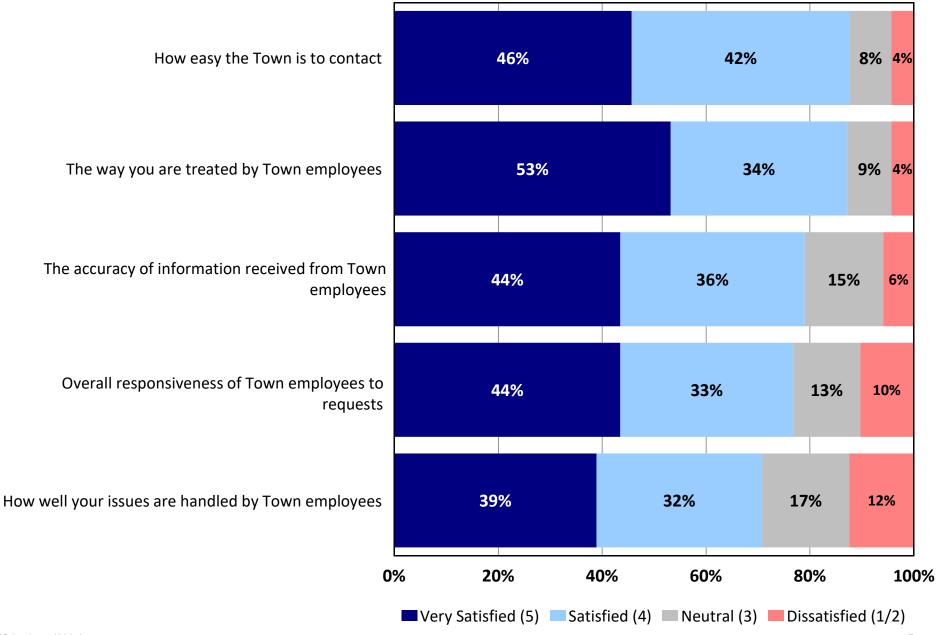
# Q7. Customer Service. Have you called or visited the Town with a question, problem or complaint during the past year?

by percentage of respondents (excluding "don't know")



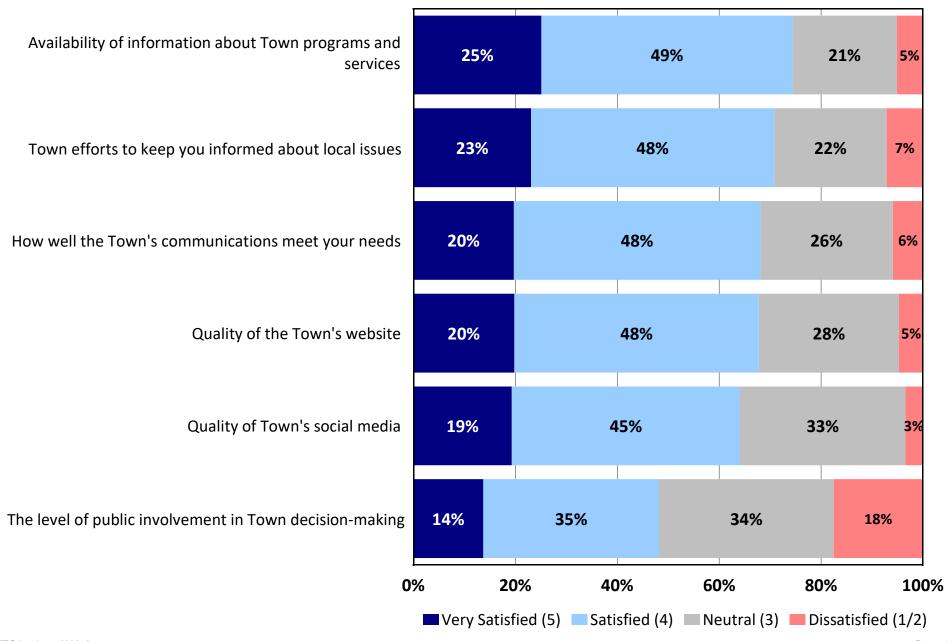

by percentage of respondents who answered "yes" to Q7 (excluding "don't know")



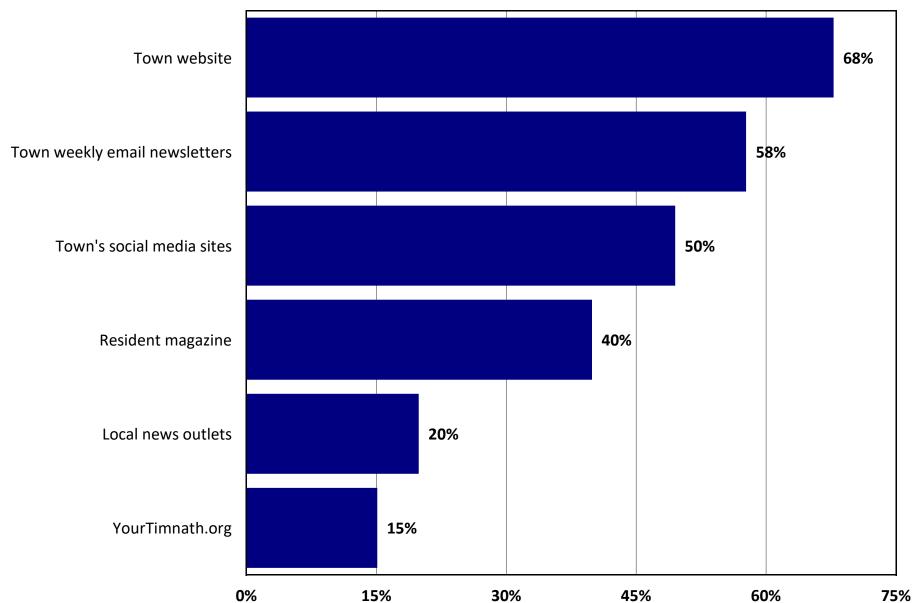
#### Q8. Communication. Please rate your satisfaction with each

by percentage of respondents (excluding "don't know")



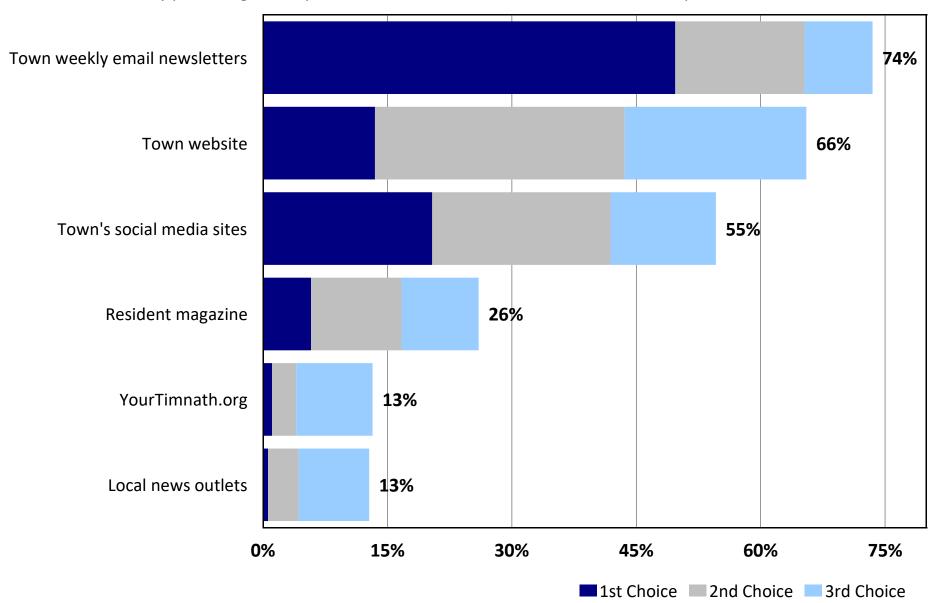
## Q9. Please CHECK ALL the sources of information listed below that you currently use to obtain or receive information about the Town of Timnath.

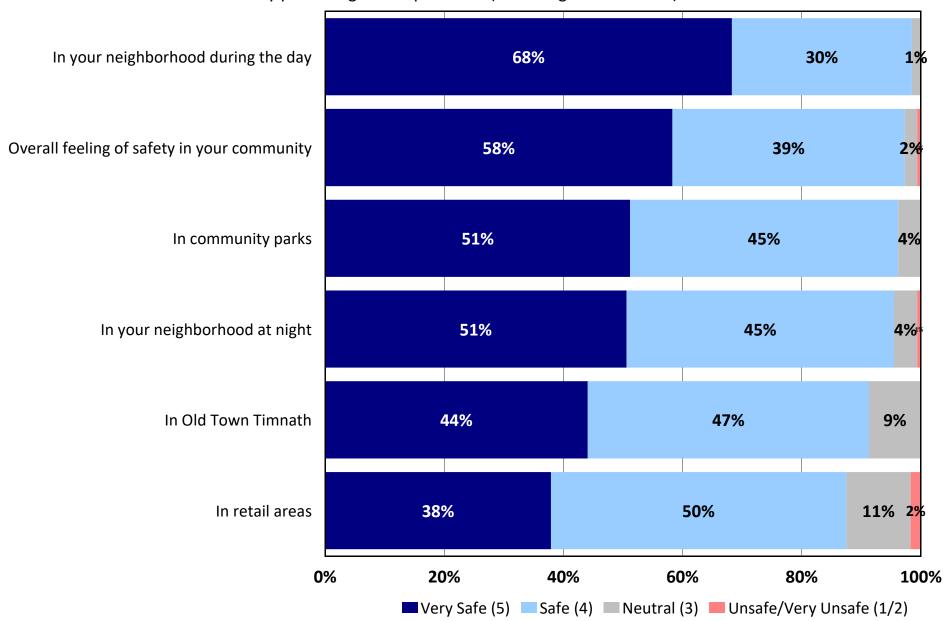
# Q10. From which THREE sources of information listed in Question 9 would you MOST PREFER to get information from the Town of Timnath?

by percentage of respondents who selected the item as one of their top three choices



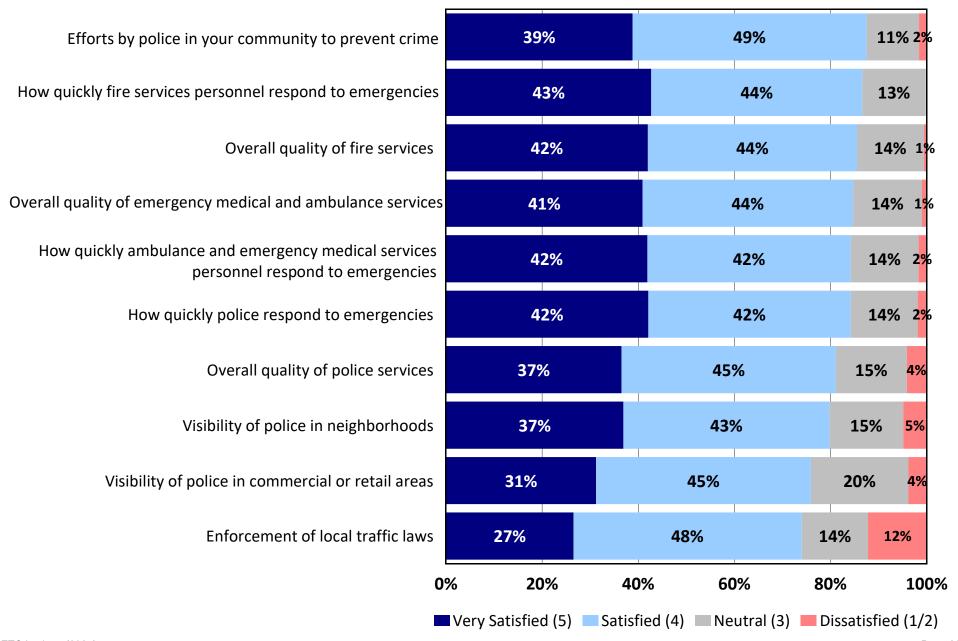

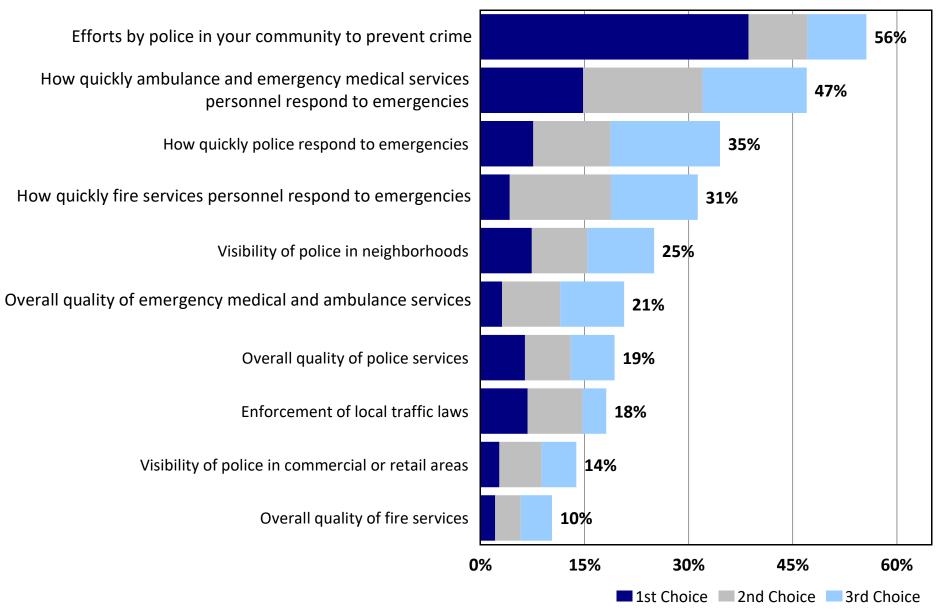

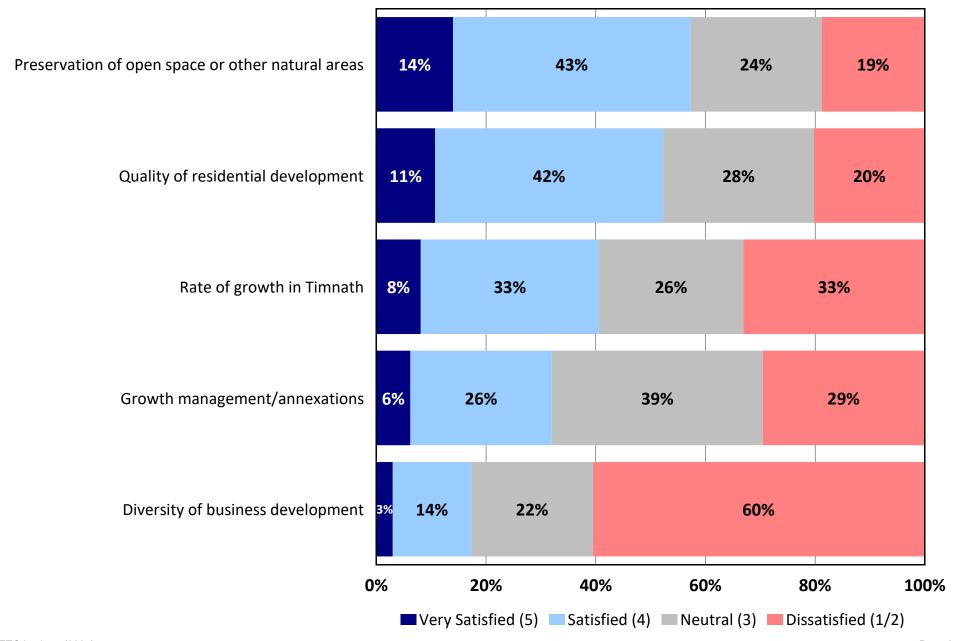
# Q13. Which THREE of the public safety services listed in Question 12 do you think are MOST IMPORTANT for the Town to provide?

by percentage of respondents who selected the item as one of their top three choices



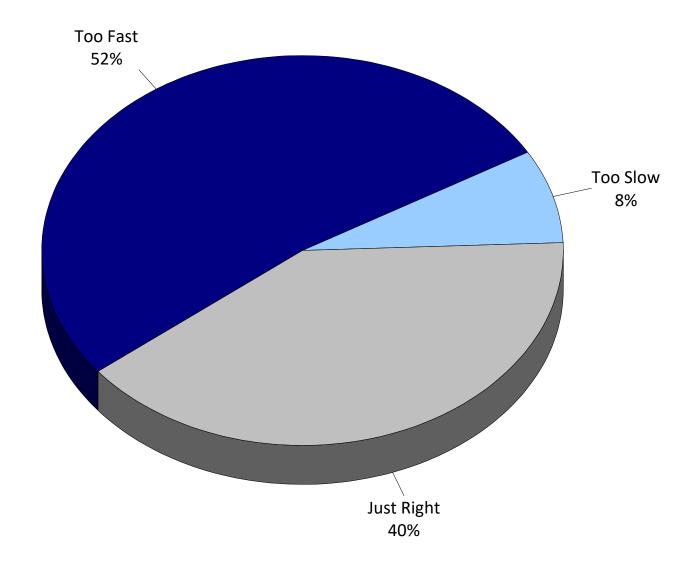

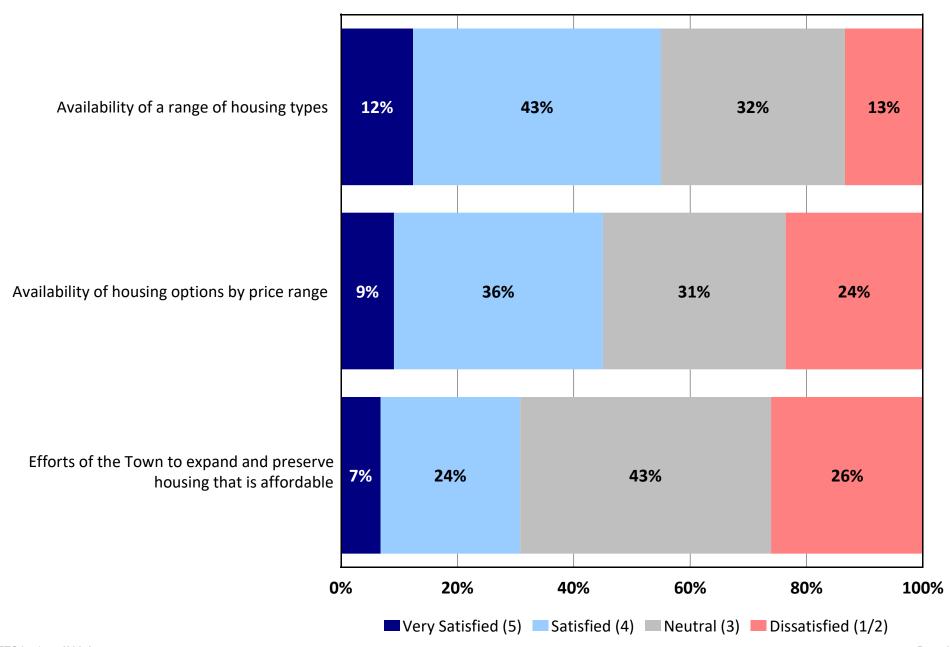
#### Q15. Do you think the growth rate in Timnath is...

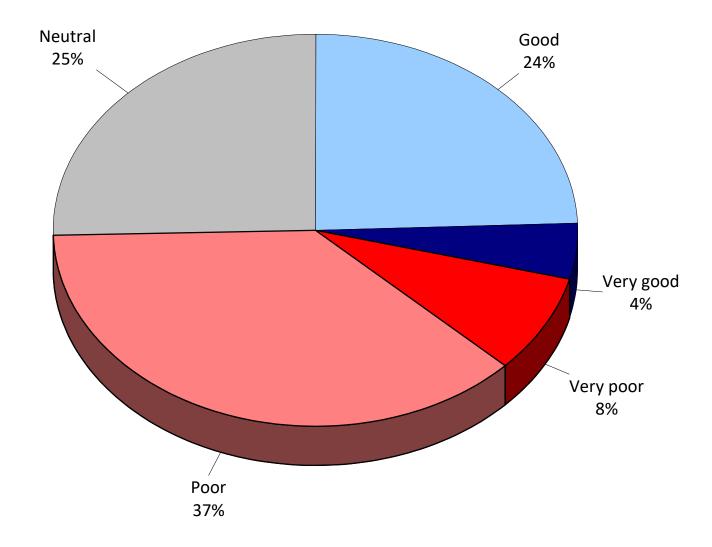

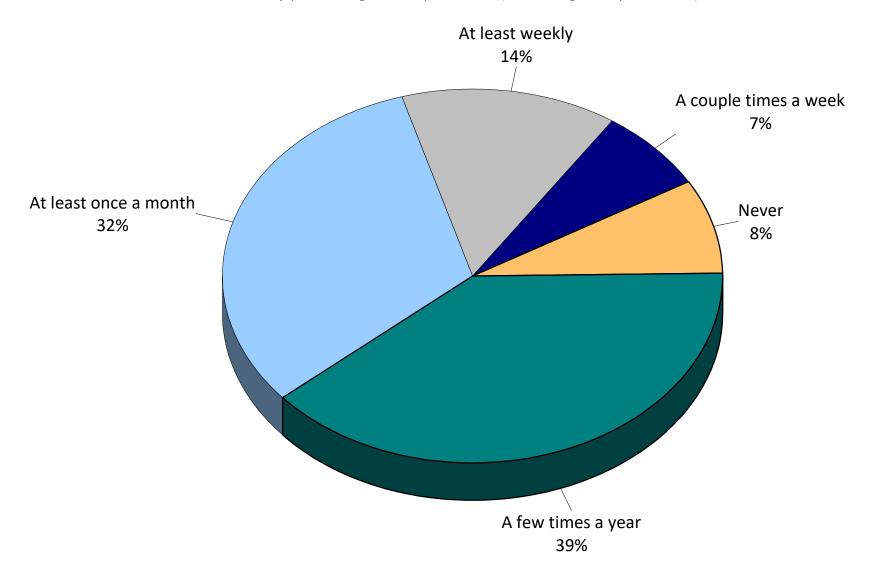
#### Q17. How would you rate the overall quality of downtown Timnath (Old Town)?

by percentage of respondents (excluding "not provided")



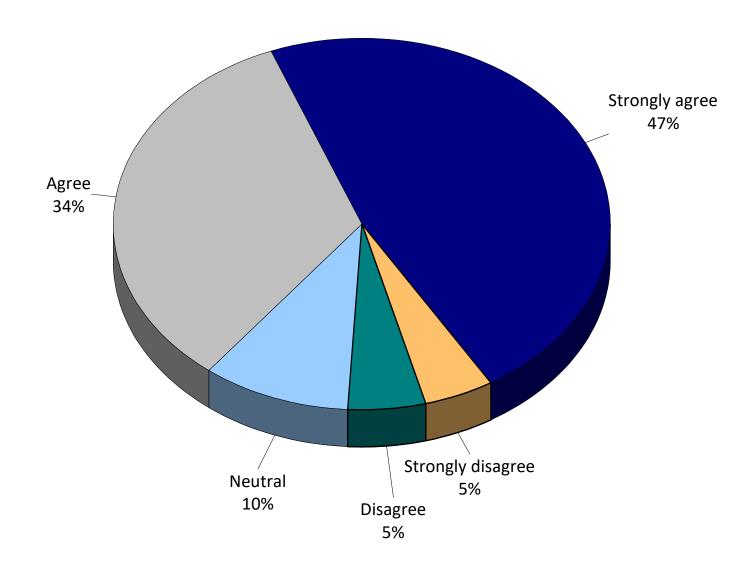
# Q18. In the last 12 months, how many times have you or a member of your household visited downtown Timnath (Old Town)?

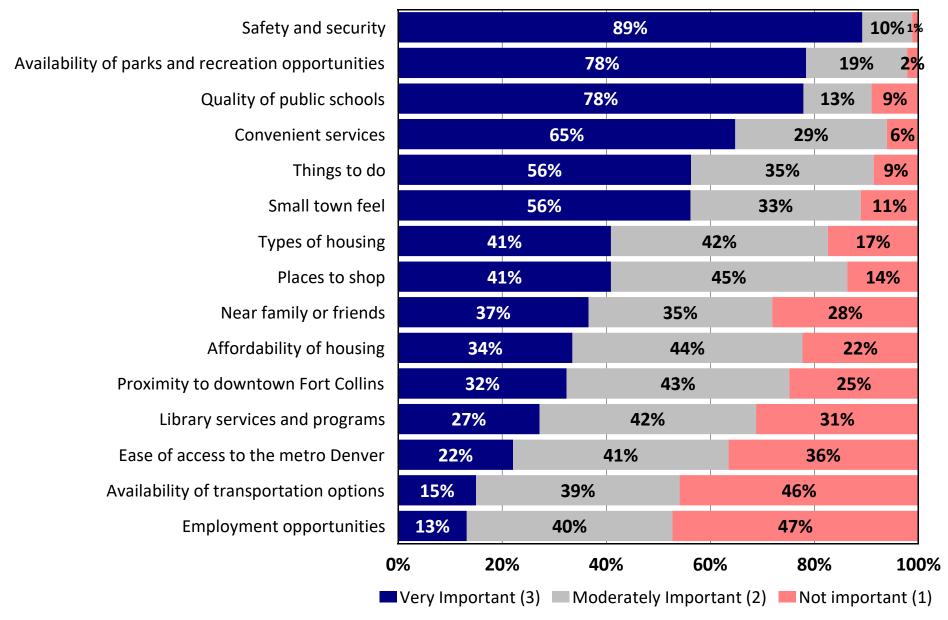

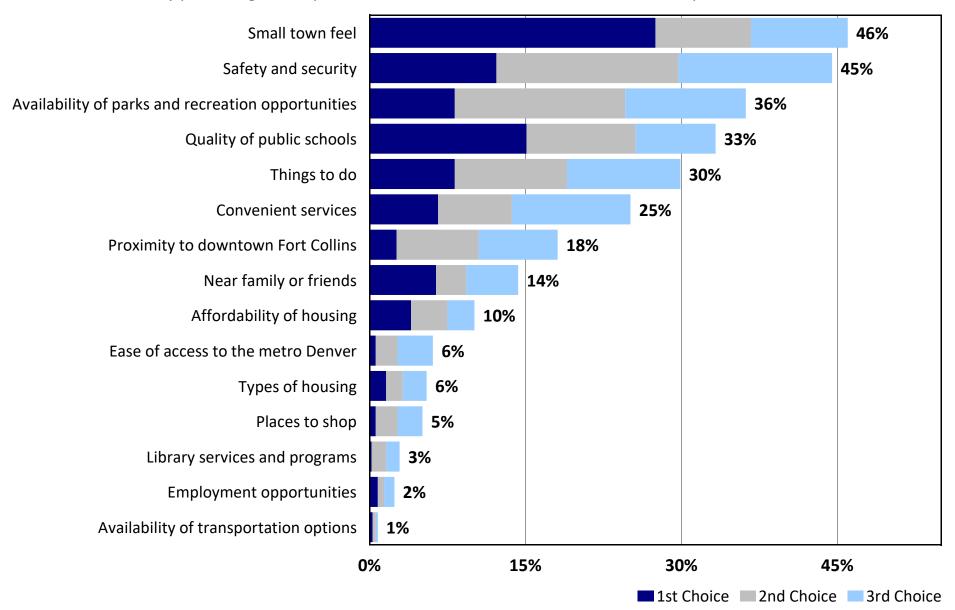
## Q20. Reasons to Live in Timnath. Please rate how important each reason is to your decision to live in Timnath.

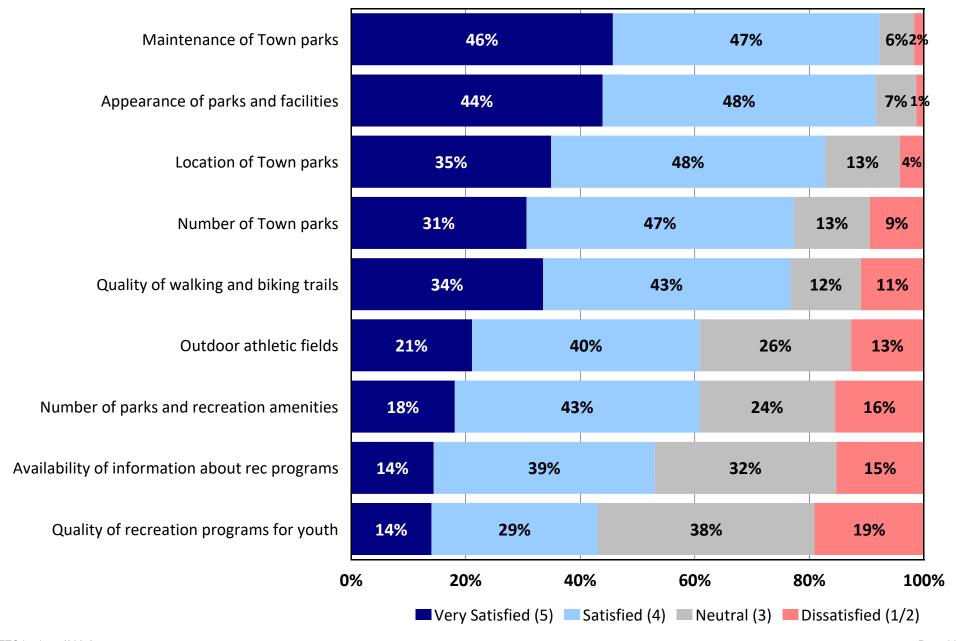
# Q21. Which THREE of the items listed in Question 20 will have the biggest impact on your reasons for staying in Timnath?

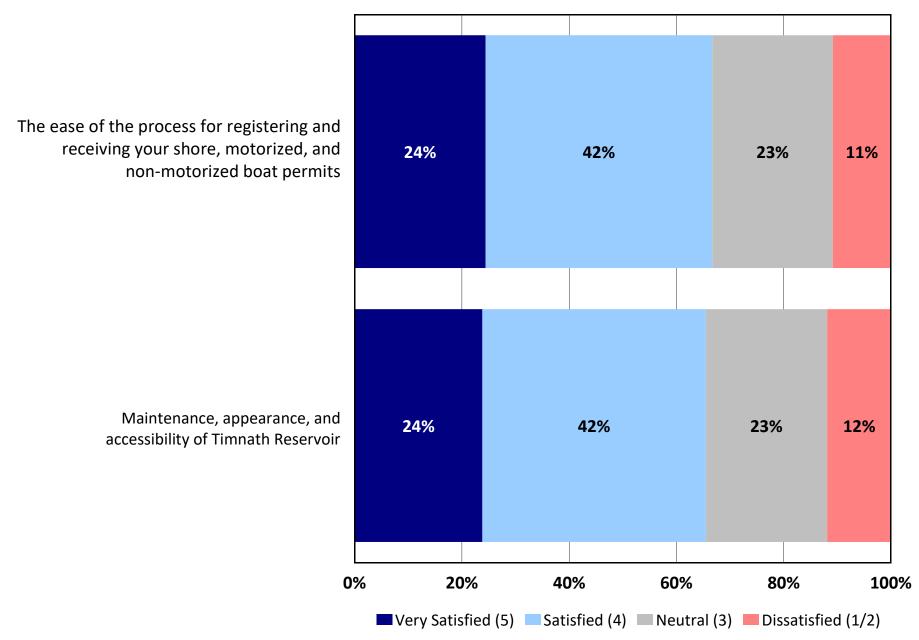

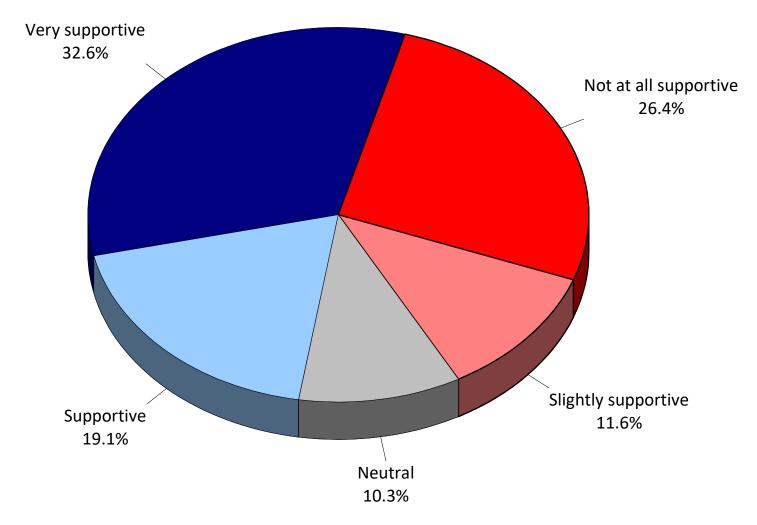

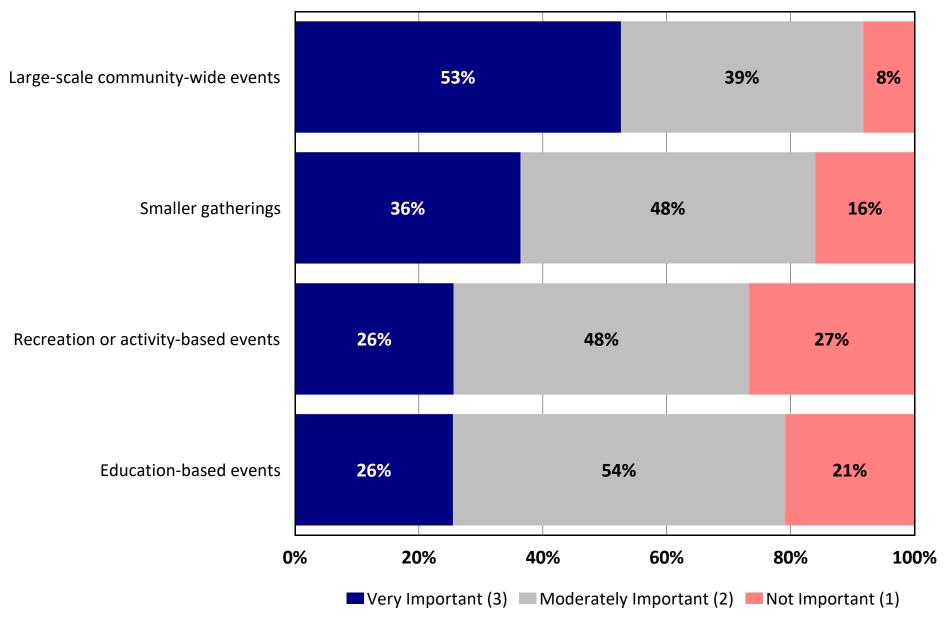

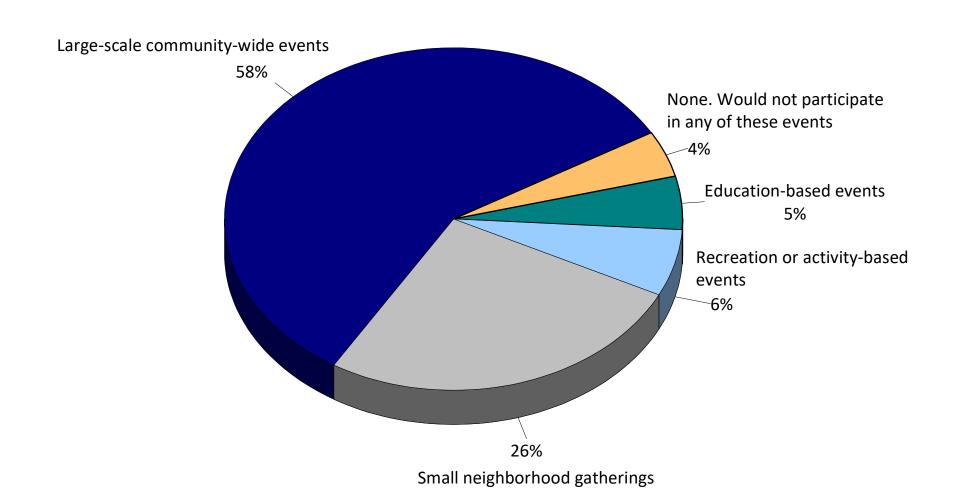
# Q25. Please rate how important you believe each of the following event types are to the community in Timnath.

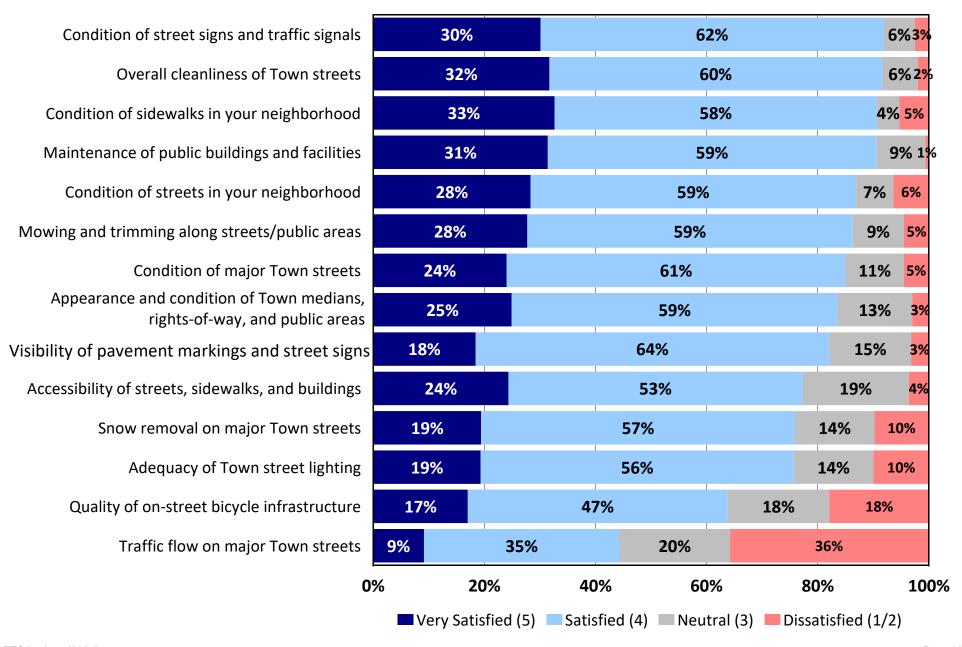

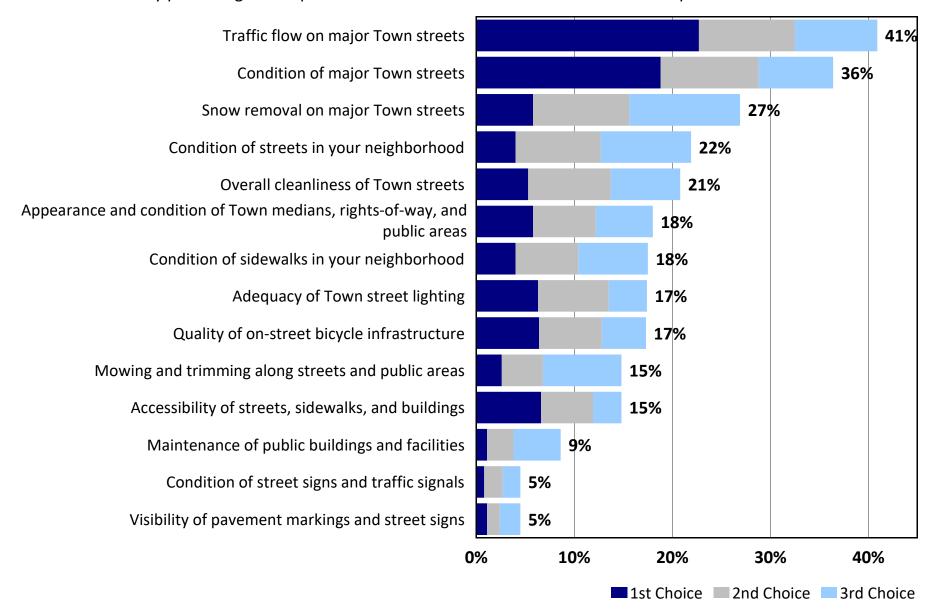

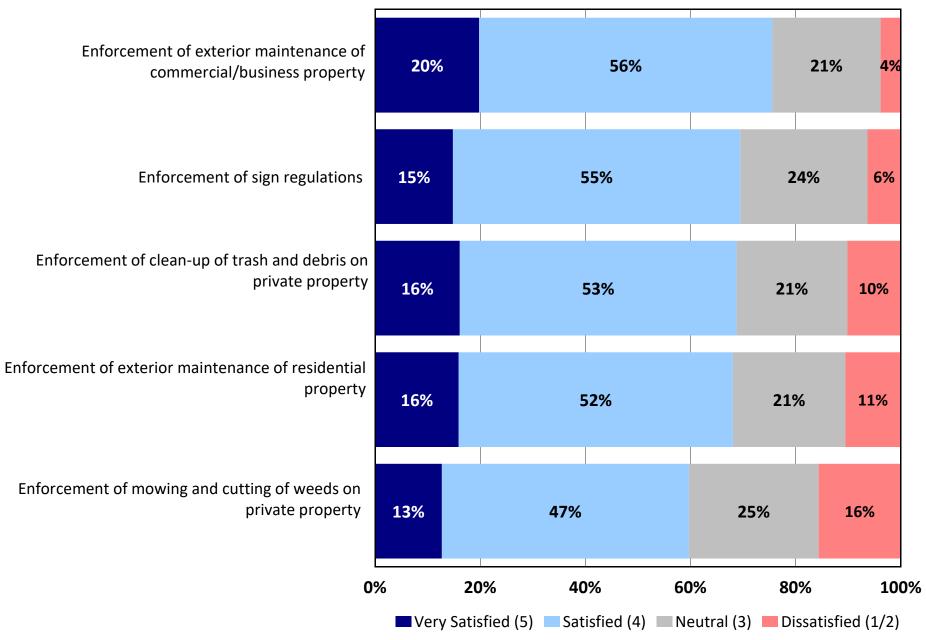
### Q29. Which THREE of the maintenance and appearance of the Town services listed in Question 28 do you think are MOST IMPORTANT for the Town to provide?

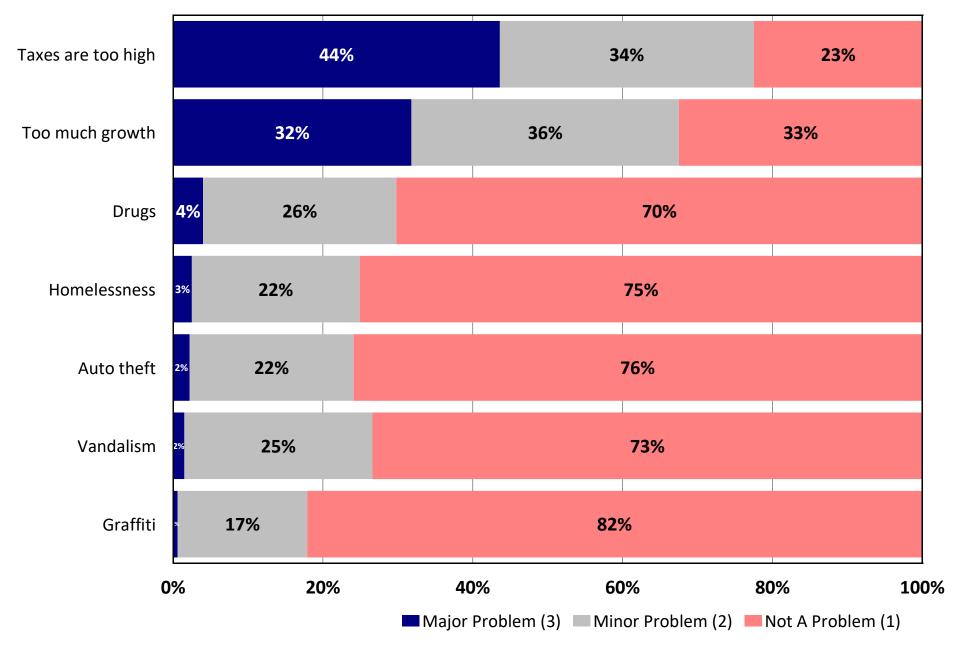

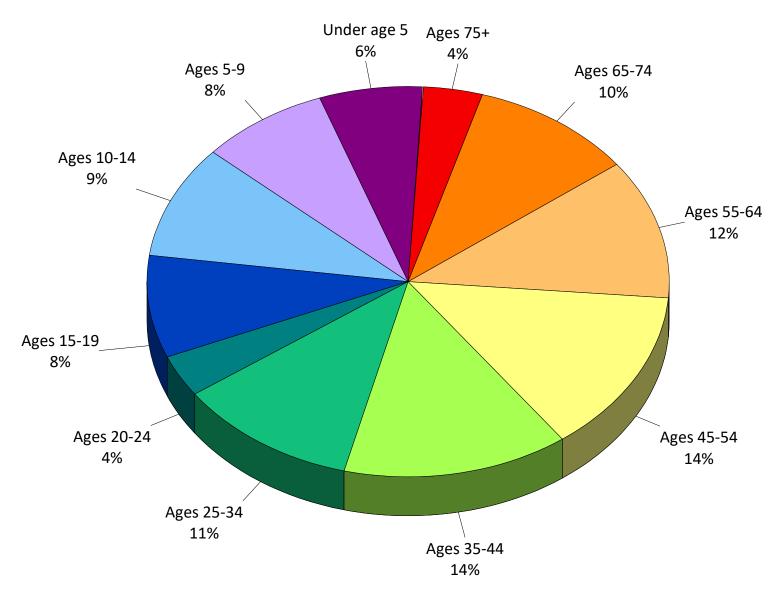
#### Q31. To what degree, if at all, are the following a problem in Timnath?

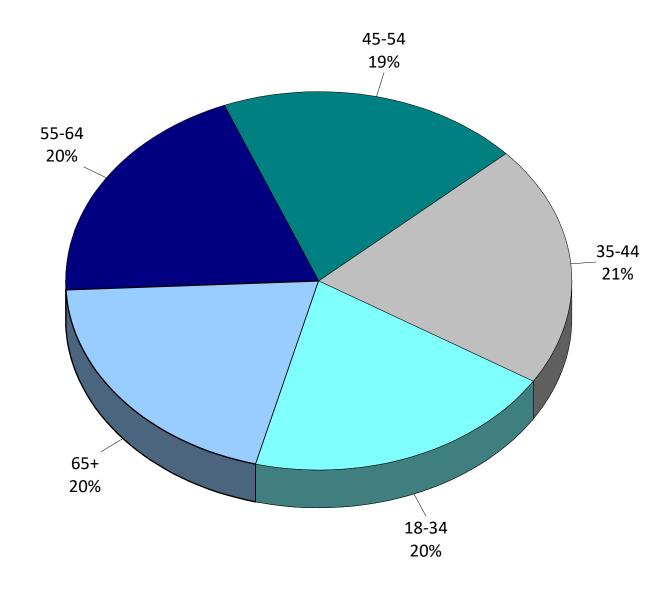

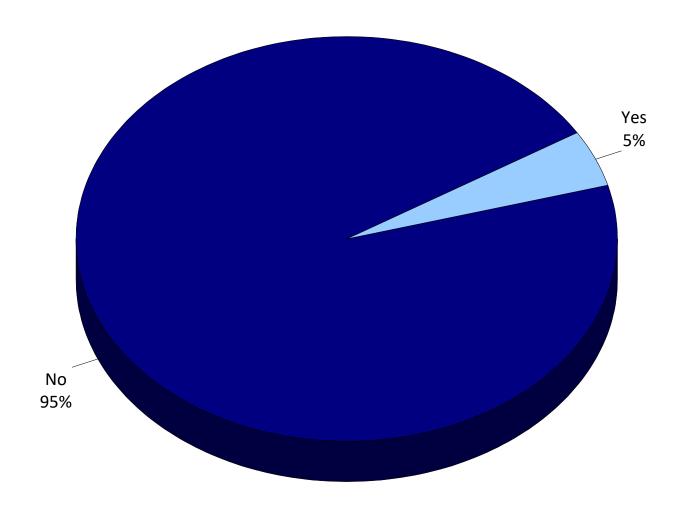

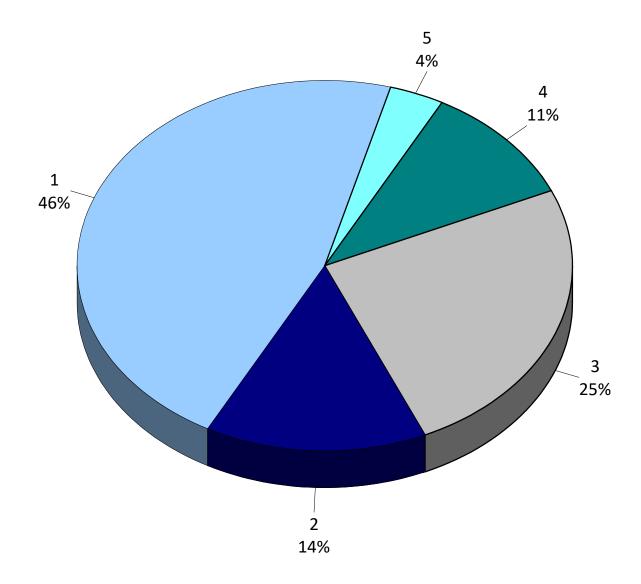

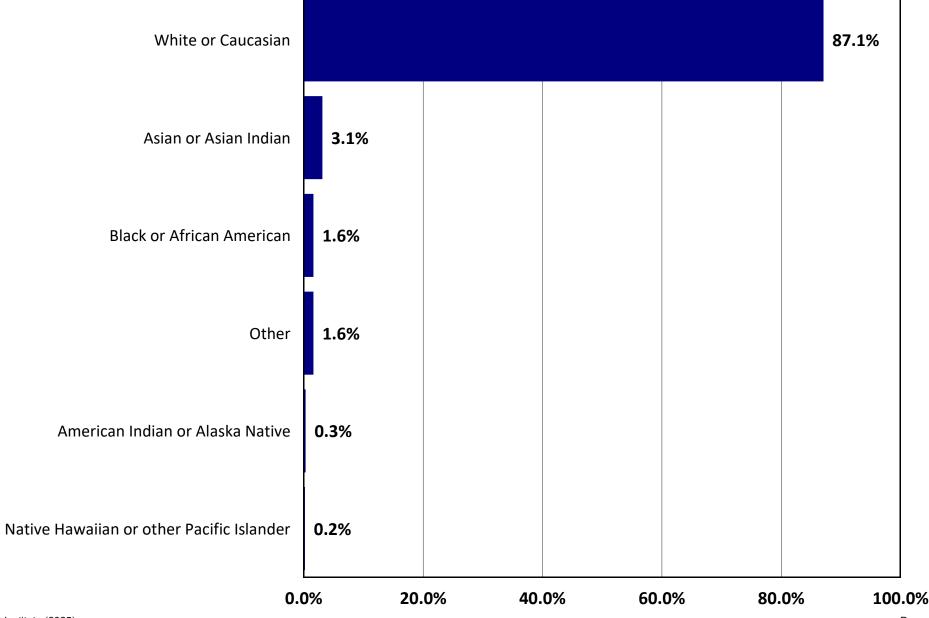
# Q34-1. How many members of your family are of Hispanic, Spanish, or Latino/a/x ancestry?

by percentage of respondents who responded "yes" to Q34 (excluding "not provided")



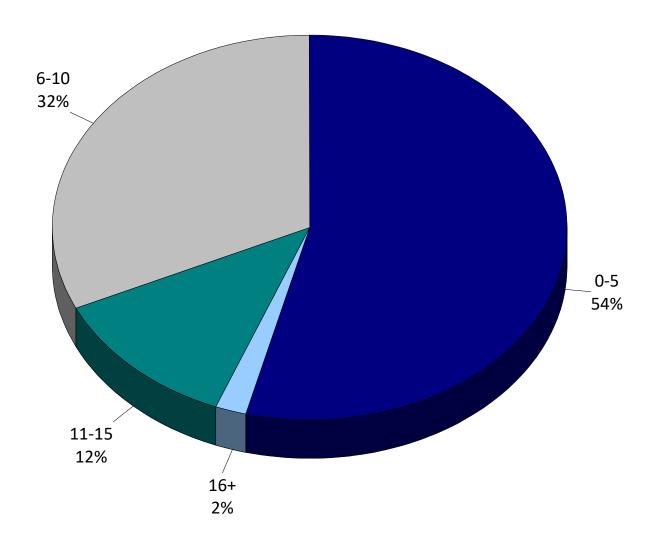
#### Q35. Which of the following best describes your race/ethnicity?

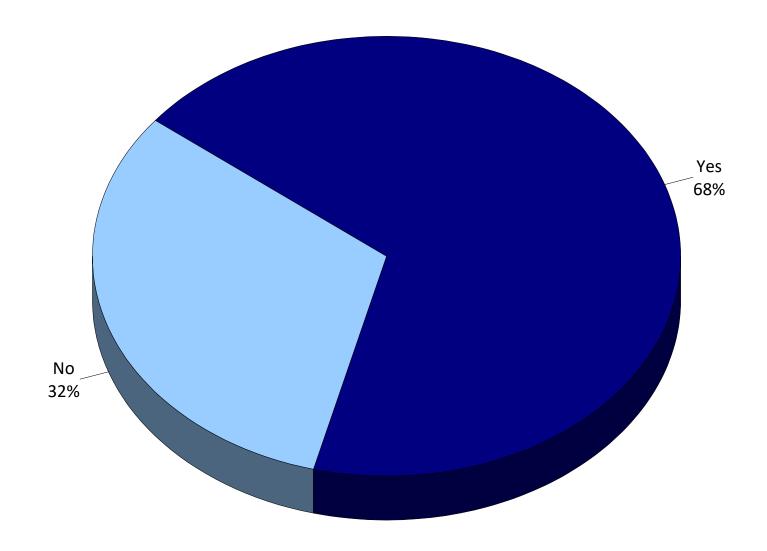

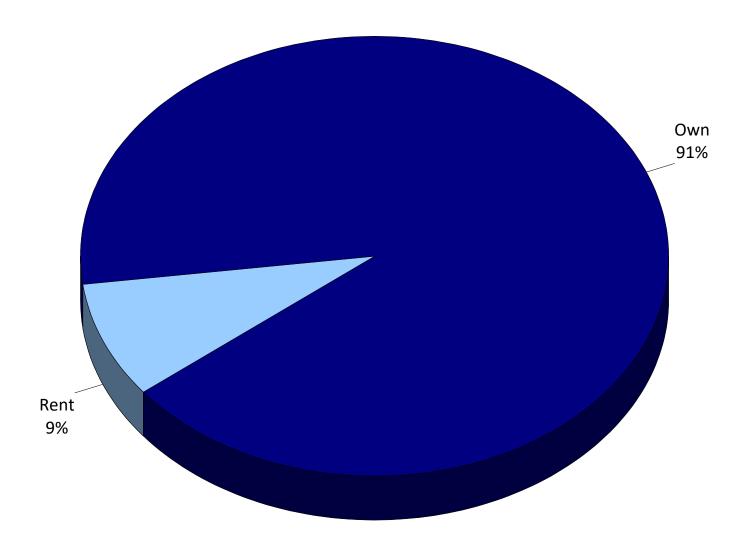

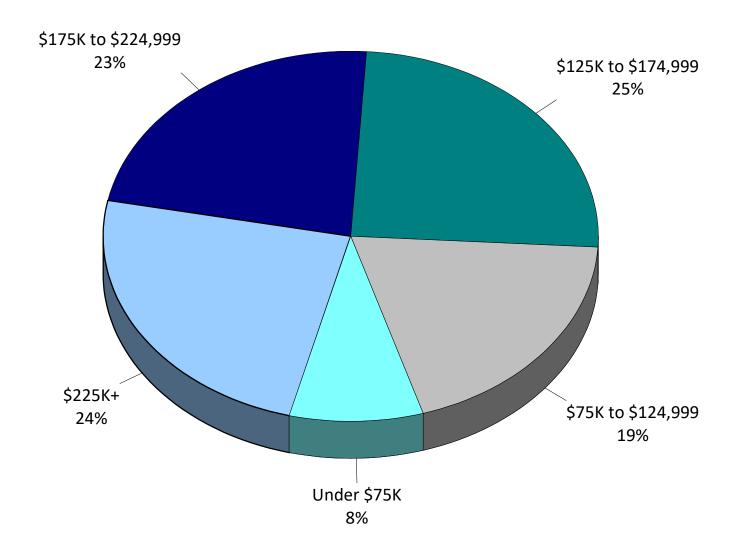
### Q38. Do you own or rent your current residence?

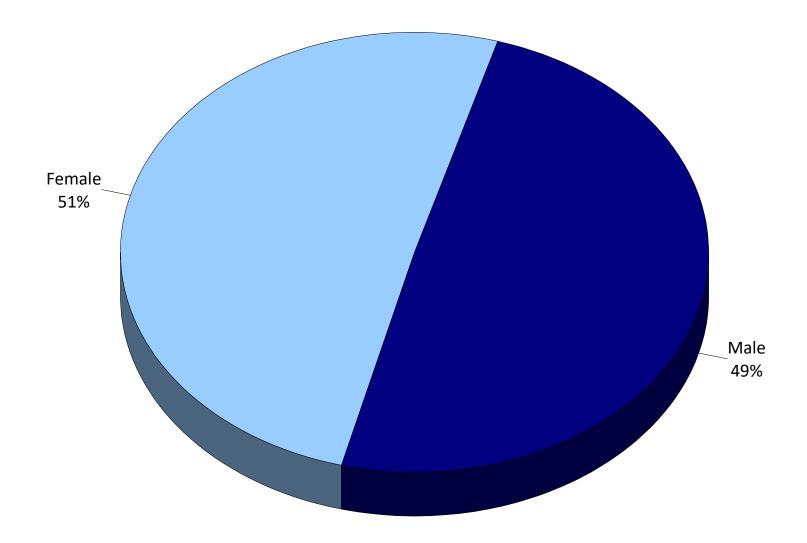

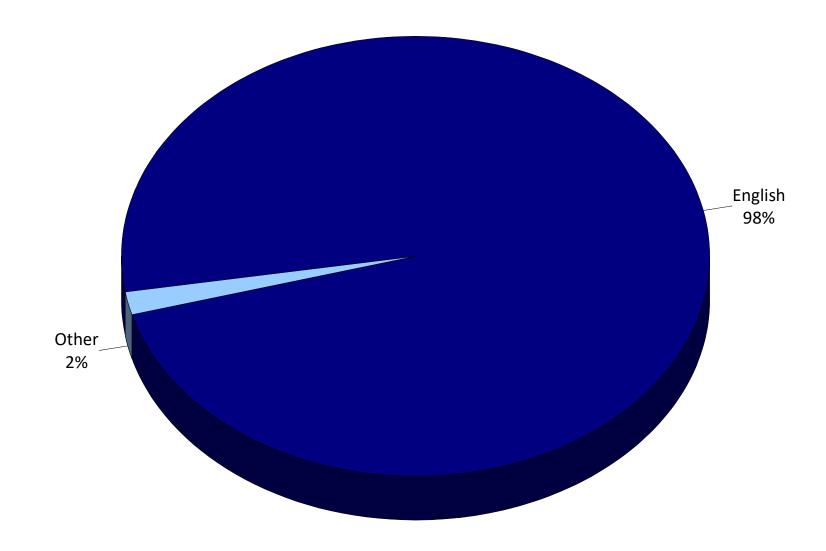

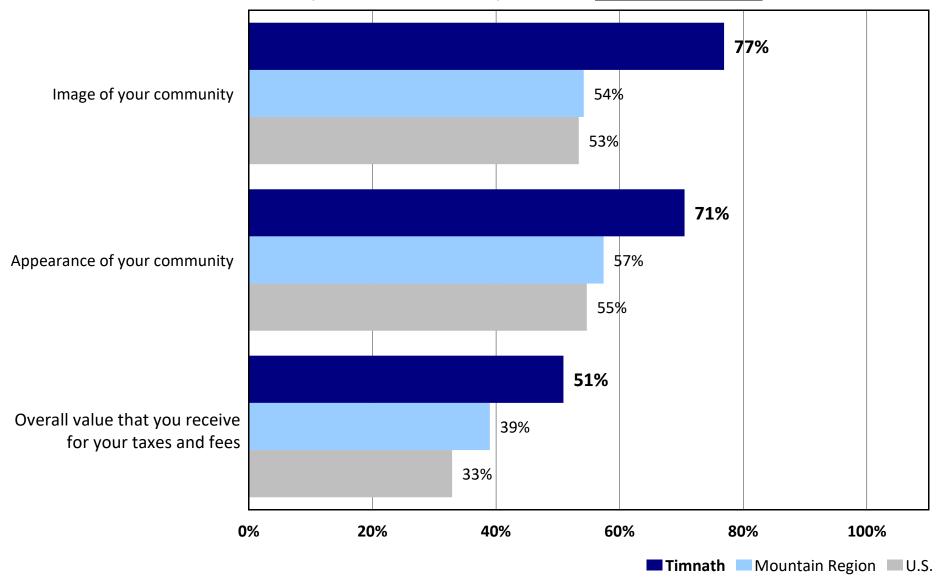

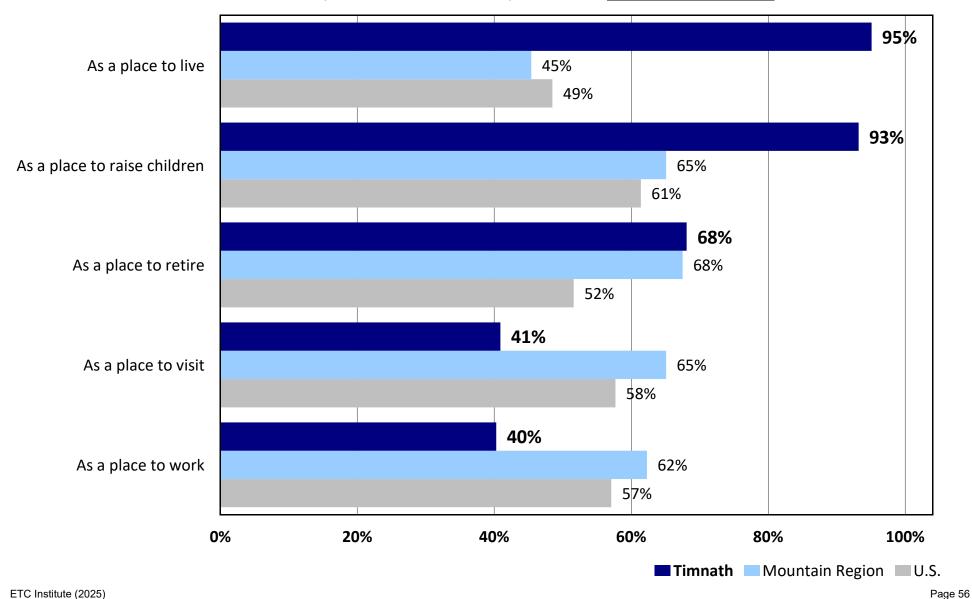
# Perceptions of Community <u>Timnath vs. Mountain Region vs. U.S. Average</u>

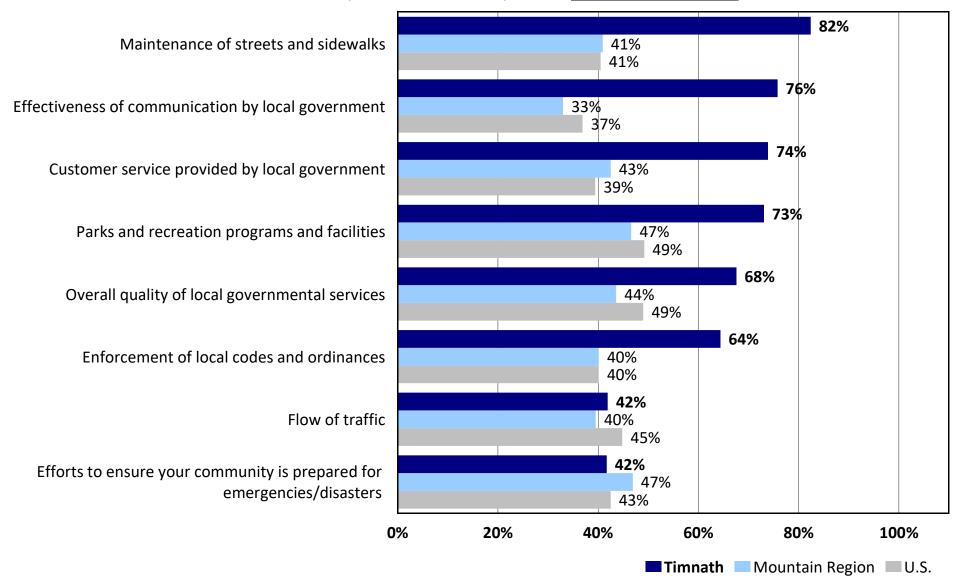
### **Overall Ratings** Timnath vs. Mountain Region vs. U.S. Average

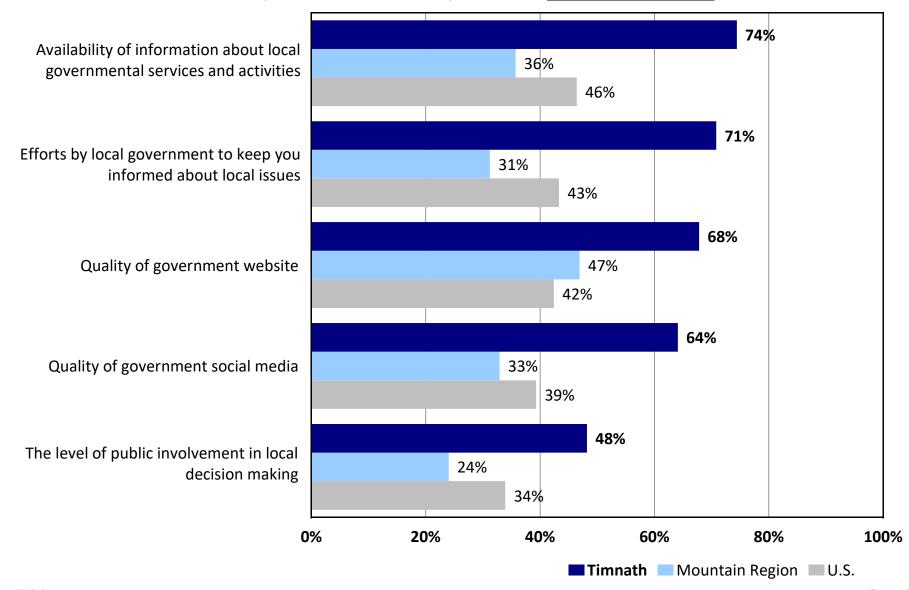
# Major Town Services <u>Timnath vs. Mountain Region vs. U.S. Average</u>

by percentage of respondents who rated the item 4 or 5 on a 5-point scale where 5 was "very safe" and 1 was "very unsafe" (excluding don't knows)



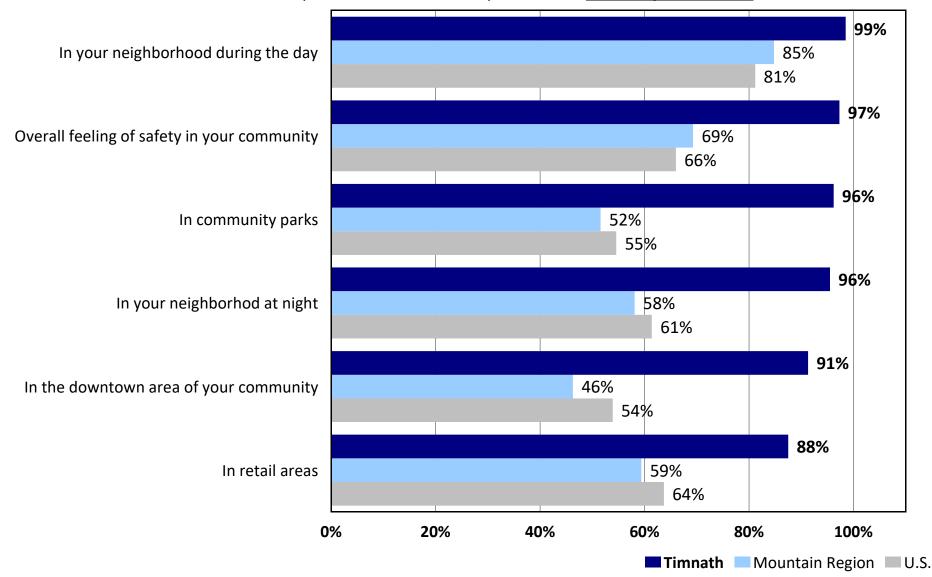
# Communication Timnath vs. Mountain Region vs. U.S. Average

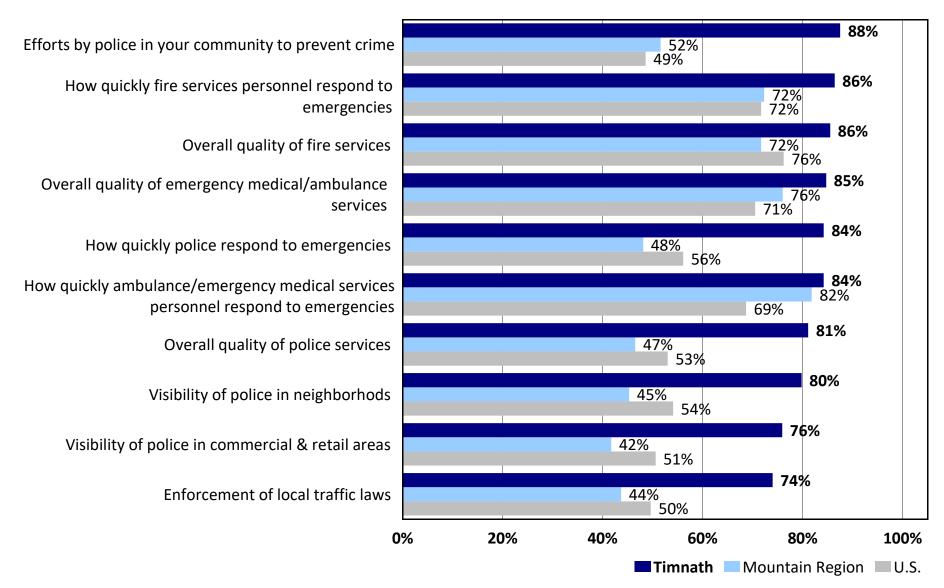

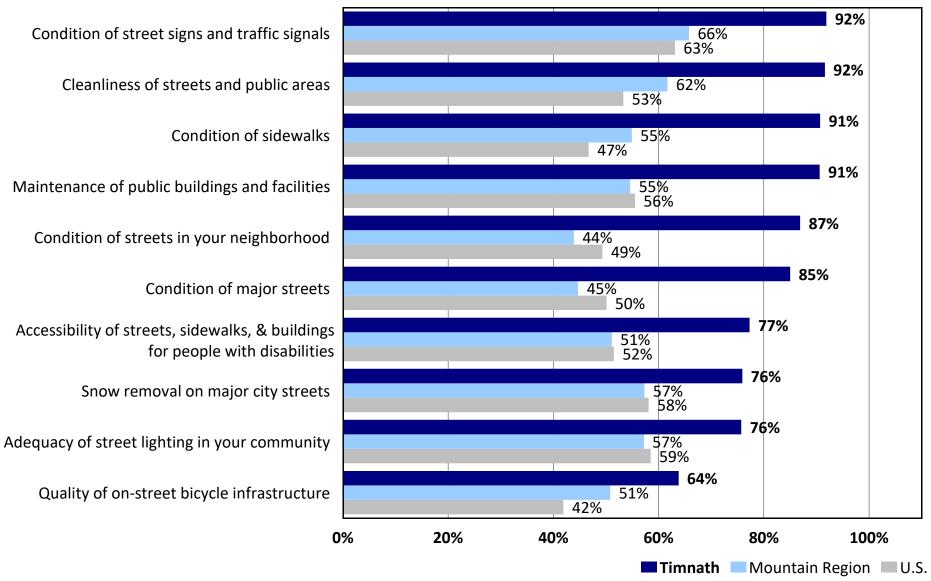

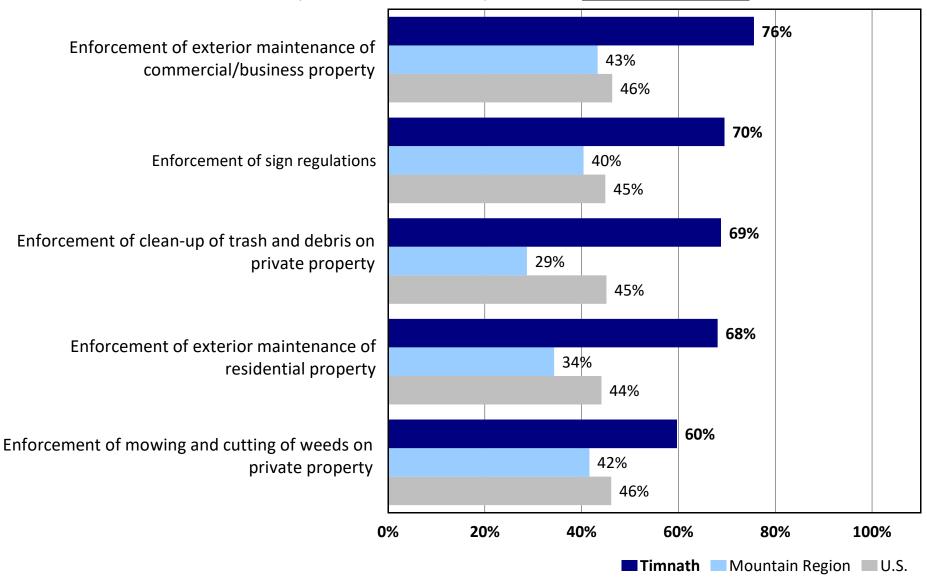
# Maintenance and Appearance of the Town Timnath vs. Mountain Region vs. U.S. Average

# Importance-Satisfaction Analysis Timanth, CO

#### Overview

Today, city officials have limited resources which need to be targeted to actions that are of the most benefit to their citizens. Two of the most important criteria for decision making are (1) to target resources toward services of the <u>highest importance to citizens</u>; and (2) to target resources toward those services where citizens are the least satisfied.

The Importance-Satisfaction (IS) rating is a unique tool that allows public officials to better understand both of these highly important decision-making criteria for each of the services they are providing. The Importance-Satisfaction rating is based on the concept that public agencies will maximize overall customer satisfaction by emphasizing improvements in those areas where the level of satisfaction is relatively low, and the perceived importance of the service is relatively high.

#### Methodology

The rating is calculated by summing the percentage of responses for items selected as one of the most important items for the city to provide. The sum is then multiplied by 1 minus the percentage of respondents who indicated they were positively satisfied with the city's performance in the related area (the sum of the ratings of 4 ("good") and 5 ("excellent") on a 5-point scale excluding "don't know" responses). "Don't Know" responses are excluded from the calculation to ensure the satisfaction ratings among service categories are comparable. [IS=Importance x (1-Satisfaction)].

**Example of the Calculation:** In an example scenario, respondents were asked to rate their satisfaction parks and facilities then select the top three most important aspects to their household. In this example, twenty-eight percent (28%) of respondents selected *quality/number of outdoor amenities* as one of the most important services.

Regarding satisfaction, 73% of respondents rated the city's overall performance in the *quality/number* of outdoor amenities as a "4" or "5" on a 5-point scale (where "5" means "Very Satisfied") excluding "Don't Know" responses. The I-S rating for *quality/number* of outdoor amenities was calculated by multiplying the sum of the most important percentages by 1 minus the sum of the satisfaction percentages. In this example 28% was multiplied by 51% (1-0.73). This calculation yielded an I-S rating of 0.0750 which ranked 3rd out of 15 city services.

The maximum rating is 1.00 and would be achieved when 100% of the respondents select an item as one of their top three choices and 0% indicate they are positively satisfied with the delivery of the service.

The lowest rating is 0.00 and could be achieved under either of the following two situations:

- If 100% of the respondents were positively satisfied with the delivery of the service
- If none (0%) of the respondents selected the service as one for the three most important areas for the Town to emphasize over the next two years.

#### **Interpreting the Ratings**

Ratings that are greater than or equal to 0.20 identify areas that should receive significantly more emphasis over the next two years. Ratings from 0.10 to 0.20 identify service areas that should receive increased emphasis. Ratings less than 0.10 should continue to receive the current level of emphasis.

- Definitely Increase Emphasis (IS>=0.20)
- Increase Current Emphasis (0.10<=IS<0.20)
- Maintain Current Emphasis (IS<0.10)

- The only shopping available is Costco and Walmart. Would like to have a King Soopers or some Grocery Store. More restaurants would be nice. There are only fast food restaurants in the town.
- The overall businesses Timnath is getting. We are an upscale neighborhood/town, yet we have an old Walmart, Costco, lower quality fast food, liquor stores, very bright neon lighted carwash?? On the horizon doesn't look good either La Quinta hotel (which are known for drug dealers), storage units, more cheap fast food. I have no where to shop for groceries unless I drive for miles. No restaurants. No nice coffee shops or lunch places where people can meet up. No rec centers. What about a Whole Foods, decent restaurants, nice hotel/conference center like the Westin in Westminster, Lifetime Fitness, walkable restaurant/shops area? Just some ideas. The 2 shopping area's are a nightmare to get in/out of. I'm a part time resident and really having a problem making Timnath a permanent home. We come from the Westminster/Broomfield area where everything is within a mile.

Especially not having a recreation center with workout space and pool. Another very large downside is there are no restaurants in town. We keep getting fast food at the I25 exchange, but nothing authentic and good. Chicken and Donuts went in, but they have vetoed all other restaurant style places from going in near them and they do not offer a variety of food. I would like to see more quality, not chain restaurants go in.
